Susquehanna, Bradford, Tioga, Potter, McKean, Centre, Clearfield and Lycoming, and they are hereby authorised and empowered, with the assistance of the township assessors respectively, to extend the road tax now allowed by law, to any sum not exceeding one cent in the dollar on the valuation, in any one year, (if the same shall be found necessary in any township) for opening and keeping the public highways in repair: which tax shall be levied, collected and applied by the supervisors in like manner, and subject to all the penalties contained in the act to which this is a further supple-

CHAPTER LXXXIX.

AN ACT

To authorise the Auditor General to settle and adjust the accounts of the Treasurers and Managers of the Susquehanna Lottery.

SECT. 1 BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same. That the Auditor General be and he is hereby authorised and required, to adjust and settle the accounts of William P. to settle ac-Beatty, treasurer, and the managers of a lottery to raise a sum counts. of money to improve the navigation of the Susquehanna, and certain branches thereof, agreeably to the provisions of the act of the legislature, passed the eighteenth day of February, one thousand eight hundred and five, and a supplement thereto passed the thirty-first day of March, one thousand eight hundred and six.

SECT. 2. And be it further enacted by the authority aforesaid. That in case the said treasurer and managers shall neglect or refuse to render their accounts, to the satisfaction Proceedings of the Auditor General, within six months from and after the gers refuse passage of this act, the Auditor General is hereby authorised to render and required to direct the Attorney General, or his deputy, their acto bring a suit or suits in the name of the Commonwealth, counts.

CHAPTER XC.

AN ACT

For the relief of the heirs of Ezekiel Sanky, an old soldier.

WHEREAS it appears to the legislature, that Ezekiel Sanky, a private of the third Pennsylvania regiment in the revolutionary war, was entitled to a tract of donation land of two hundred acres, which he did not draw in his lifetime, nor any person since his decease; and it is but just that his heirs and legal representatives should be compensated out of the state treasury for the value thereof:

Therefore,

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the State Treasurer be, and he is hereby directed to pay to the heirs or legal representatives of Ezekiel Sanky, late of York county, deceased, the sum of three hundred dollars, in lieu of a tract of donation land to which he was entitled in his lifetime.
