CHAPTER CXXII.

ANACT

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the State Treasurer be, and he is hereby authorised and required to pay to Daniel Gridley of Luzerne county.
