### CHAPTER XXX.

# AN ACT

For the relief of Jefferson, Washington and Allegheny Colleges.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the State Treasurer be, and he is hereby authorised and directed to pay the trustees of Jefferson college, or order, the sum of one thousand dollars annually for five years, to commence on the first of January, one thousand eight hundred and twenty.

Secr. 2. And be it further enacted by the authority aforesaid. That the State Treasurer be, and he is hereby authorised and directed to pay to the trustees of Washington college, or order, the sum of one thousand dollars annually for five years, to commence on the first day of January, eighteen

hundred and twenty.

Allegheny college.

SECT. 3. And be it further enacted by the authority aforesaid, That the State Treasurer be, and he is hereby authorised and directed to pay to the trustees of Allegheny college, or order, the sum of one thousand dollars annually for five years, to commence on the first day of January, one thousand eight hundred and twenty.

## CHAPTER XXXI.

# A FURTHER SUPPLEMENT

To the act, entitled "An act laying a tax on dogs in certain counties, and for other purposes."

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General

Assembly met, and it is hereby enacted by the authority of the same, That when, and as often as the commissioners of the Returns of city and county of Philadelphia, agreeably to the directions dogs and asof the act to which this is a supplement, shall have caused sessments of an accurate return to be made of all dogs upwards of one tax to be demonth old, owned or possessed by any person or persons re-livered to siding within the city of Philadelphia, the district of South-the poor. wark and the township of the Northern Liberties, (including Penn township, Kensington, and the township of Germantown;) and when, and as often as they shall have caused to be levied the tax or taxes imposed by the act to which this is a supplement, and shall have decided upon appeals from the said levy or assessment, it shall be their duty, and they are hereby required to deliver the said returns and assessments to the guardians of the poor of the city of Philadelphia, the district of Southwark, and the township of the Northern Liberties, and Germantown, and it shall be the duty of the said guardians, and they are hereby required to cause the taxes so assessed to be entered upon the proper duplicates of the poor tax, and the collectors of the poor taxes shall then Dog tax to be collect the said tax upon dogs, in the same manner and with the duplithe like powers as they are now authorised to collect the cates of the poor tax, allowances to be decided upon and security, if ne-poor tax, cessary, to be taken, as allowances and security are now decided upon and taken in relation to the poor tax.
