said, That if any person or persons shall think him, her or themselves aggrieved, by any thing done in pursuance of Appeal may this act, or of any by-law or ordinance made under the au-be had to the thority of the same, except what relates to the assessing and court of comcollecting of the borough tax, and appointments made by the mon pleas. burgess and council as aforesaid, he, she or they may appeal to the next court of common pleas to be held for the same county, upon giving security according to law, to prosecute his, her or their appeal with effect, and the said court having taken such order therein as shall seem to them just and reasonable, the same shall be conclusive and bind all parties.

SECT. 18. And be it further enacted by the authority aforesaid, That the act, entitled "An act to erect the town of Repeal of Lebanon, in the county of Dauphin, into a borough," passed former act, the twenty-eighth day of March, one thousand seven hundred and ninety-nine, be, and the same is hereby repealed.

CHAPTER XXXIV.

AN ACT

For the relief of Dickinson College.

Short. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That as soon as the trustees of Dickinson college shall, by deed duly executed, convey in fee simple to this common-\$6,000 to be wealth all the lands heretofore granted by the state to the paid to trussaid college, which they have not heretofore transferred, and teess cause the same to be recorded in the different counties where such lands lie, and shall assign and set over to this commonwealth all securities for the purchase money which they have taken, for such portions of the said lands as they have heretofore sold, it shall be lawful for the Governor, and he is hereby required to draw his warrant on the State Treasurer in favor of the trustees of the said college, for the sum of six

thousand dollars, to be applied to the payment of the debts due by the said college, and making necessary repairs: Provided, That it shall be the duty of the said trustees, (on the said purchase money being paid into the state treasury,) at the request of the State Treasurer, to make deeds to the purchasers of said lands pursuant to the contracts heretofore entered into between the respective parties.

Secr. 2. And be it further enacted by the authority aforesaid, That the Governor shall annually on the first day of \$2,000 annu-January in each and every year, for the space of five years, ally for five draw his warrant on the State Treasurer in favor of the trustees of said college for the sum of two thousand dollars, to

be applied to the support of the institution.

Lands, how to be sold.

Secr. 3. And be it further enacted by the authority aforesaid, That the lands to be transferred to the commonwealth under the first section of this act, shall not be sold on the same terms that other lands belonging to the commonwealth are now sold, but shall be reserved for future disposal as shall hereafter be directed.
