SECT. 1. SECT. 2. And be it further enacted by the authority afore-200 shares said, That when fifty persons or more shall have subscribed being subsix hundred shares, the commissioners or a majority of them scribed the shall certify under their hands and seals the names of the same to be subscribers and the number of shares subscribed to the Government, whereupon it shall and may be the lawful for the Government or by letters patent under his hand and seal of the state,

to create and erect the subscribers into one body politic and corporate, in deed and in law by the name, style, and title of "The president, managers and company of the Centre and Kishacoquillas Turnpike Road company," and by the said name the said subscribers shall have perpetual succession, and all the privileges and franchises incident to a corporation, and shall be capable of taking and holding their said capital stock and the increase and profits thereof, and of enlarging the same from time to time by new subscriptions, in such manner and form as they shall think proper, if such enlargement shall be found necessary to fulfil the intent of this act, and of purchasing, taking and holding to them and their successors and assigns, and of selling, transferring and conveying in fee simple or for any less estate, all such lands, tenements and hereditaments, and estate real and personal, as shall be necessary to them in the prosecution of their work, and of suing and being sued, and of doing all and every other matter and thing which a corporation or body politic may lawfully do, and generally have all the powers, authorities and privileges, and be subject to all the duties, qualifications, restrictions, penalties, fines and forfeitures which are given and granted to, or imposed upon the president, managers and company, in the act passed the twenty-fourth day of February, one thousand eight hundred and six, entitled "An act authorising the Governor to incorporate a company for making an artificial road from the bank of the river Susquehanna opposite the horough of Harrisburg to Pittsburg."
