this is a supplement, at the same time to make out a separate list of the deaf and dumb persons, if any, resident in their respective townships, towns, wards or districts, distinguishing their sexes, colour and as nearly as may be their several ages, and the commissioners of the several counties, shall make returns thereof to the Governor pursuant to the provisions of the second section of the act to which this is a supplement.

## CHAPTER LXVII.

## AN ACT

Authorising the trustees and elders of the German Reformed and German Lutheran congregations, of the borough of Greensburg, to sell and convey a certain lot or parcel of ground in said borough.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That Jacob Hugus and Henry Welty, trustees, and Jacob Kiehl and Jacob Steelsmith, elders of the German Reformed congregation, of the borough of Greensburg, and Peter Rugh, Philip Kuhns, John Kuhns, junior, and Christian Botzer, elders of the German Lutheran congregation of the said borough, be, and they are hereby authorised to grant, bargain and sell the whole of lot number twenty-seven, and part of lot number twenty five in said borough, commencing at Third street and extending along Main street northward sixty-live feet, and from the termination of the said sixty five feet, running westward at right angles to an alley by which the said lots are bounded; and the said elders and trustees, or a majority of them, are hereby authorised and empowered to execute a deed or deeds in fee simple to the purchaser or purchasers of the same, or any part or parts thereof.

## CHAPTER LXVIII.

## AN ACT

To confirm the title of Daniel Walp to certain real estate therein mentioned.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the title of Daniel Walp, of the township of Lehigh, in the county of Northampton, to a tract or piece of land with the appurtenances, situate in said township, containing nine acres and one hundred and eight perches, adjoining lands of Jacob Kuntz, esquire, church land and others, devised by a certain Christoph Anthony Petree, an alien, to his wife Ann Catharine Petree, by virtue of his last will and testament, dated the sixth day of April, one thousand eight hundred and fifteen, duly proved and recorded in the proper office of said county, and conveyed by the said Ann Catharine Petree to the said Daniel Walp, by her indenture bearing date the sixteenth day of December, one thousand eight hundred and eighteen, duly proven and recorded in the pro-per office of said county, is hereby confirmed as far as the same may be deficient, on account of the said Christoph Anthony Petree being an alien at the time of his devising the said land; and the said devise as well as the conveyance by the said widow, shall be to all intents and purposes as good and sufficient as if the said Christoph Anthony Petree had been a citizen of the United States of America, at the time he purchased said premises, or devised the same as aforemid: Provided, That this act shall not affect the private rights of
