herein and hereby particularly mentioned, set forth, and re-enacted, and they are hereby extended and continued until the first day of June, one thousand eight hundred and twenty-two, and no longer: *Provided*, That the provisions of this act shall not be so construed as to make any alteration in the manner of calculating interest, but in all cases the interest shall be calculated in the same manner as if this act had not been passed.

The act of the 25th of March 1817, extended and continued until the 1st of June, 1822.

Proviso.

SECT. 2. *And be it further enacted by the authority aforesaid*, That the time allowed by the act, entitled, "An act concerning certain released and uncertified lands within the limits of the seventeen townships in Luzerne county," passed the twenty-fifth day of March, one thousand eight hundred and seventeen, for any person or persons having improved or heretofore claimed any of the lands coming under the provisions of the said act, to have a preference in making application for the same, shall, and the same is hereby declared to be extended and continued until the first day of June, one thousand eight hundred and twenty-two, and no longer; *Provided*, That the preference given by the said act shall only extend to lands of which the claimant shall have had the possession, and upon which there shall have been an actual settlement on the twenty-fifth day of March, one thousand eight hundred and seventeen, and continued until the time when application shall be made for the same.

## CHAPTER CXXX.

### *AN ACT*

Relating to the appointment of the Treasurer of Bucks county.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same*, That from and after the first day of October next, no person who now is, or hereafter may become a county com-

missioner, or auditor, within the county of Bucks, shall be eligible to the office of county treasurer, until three years shall have elapsed after the expiration of his official duties as commissioner or auditor.

CHAPTER CXXXI.

*AN ACT*

For the relief of Joel Bailey, late deputy Sergeant-at-arms.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the state treasurer is hereby empowered to pay to Joel Bailey, late deputy sergeant-at-arms, the sum of one hundred and thirty-three dollars and seventy-five cents, being the amount of a warrant drawn by the Speaker of the House of Representatives, on the treasurer of Fayette county, which said sum the state treasurer shall demand and receive from the treasurer of Fayette county.
