diem, for every day necessarily employed in the duties aforesaid as a full compensation therefor; and in case of the death vacancy now or inability of either of the said commissioners, the court of supplied. quarter sessions shall, upon application to them made, appoint a suitable person or persons to carry into effect the provisions of this act.

## CHAPTER CXLIL

## AN ACT

Authorising the President and Managers of Pawlings-ford Bridge, over the river Schuylkill, to sell and transfer all their corporate rights and property.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That Levi Pawling, Joseph Crawford, Thomas Walker, George Hauch, Elijah Funk, John Francis, and John Quin; late president and managers of the company for erecting a permanent bridge over the river Schuylkill at or near Paw-lings' ford, or a majority of them, be, and they are hereby authorised and empowered to sell at public auction in the county of Montgomery or Chester, all the corporate rights. franchises, privileges and property, real, personal or mixed; of the said company, to the highest and best bidder, and to divide the proceeds thereof among the present stockholders, their assignees or legal representatives, and to execute under their hands and seals one or more good and sufficient deed or deeds, conveying and transferring the same to the purchaser or purchasers : Provided, That at least twenty days notice of the time and place of such sale shall be given in the newspapers printed in the counties of Montgomery and Chester, and one daily newspaper printed in the city of Philadelphia. And there shall be in such deed or deeds a sufficient covenant on the part of the purchaser or purchasers to build within five years from the date thereof, a permanent and substantial bridge, similar to either of those over the Delaware at New Hope, or Schuylkill at Reading. And provided also, That the said purchaser or purchasers shall be entitled to receive the same tolls arising from the said bridge, and be subject to all the restrictions prescribed by the act, entitled, "An act to authorise and direct the Governor to incorporate a company for erecting a permanent bridge over the river Schuylkill, at or near Pawlings-ford, in the counties of Montgomery and Chester," passed the third day of April, eighteen hundred and nine.

## CHAPTER CXLIII.

## A SUPPLEMENT

To the act laying a tax on dogs in the counties of Washington and Fayette and for other purposes, and repealing the act laying a tax on dogs, so far as the same relates to the county of Greene.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the act, entitled, "A supplement to an act laying a tax on dogs in certain counties, and for other purposes," March, 1817, passed the twenty-fifth day of March, in the year of our Lord one thousand eight hundred and seventeen, be, and the same is hereby repealed, so far as the same respects the county of Greene.
