## A PROCLAMATION

I, GIFFORD PINCHOT, Governor of the Commonwealth of Pennsylvania, have caused this proclamation to issue, and in compliance with the provisions of article four, section fifteen of the Constitution thereof, do hereby give notice that I have filed in the Office of the Secretary of the Commonwealth, with my objections thereto, the following bills passed by both Houses of the General Assembly, viz:

House Bill No. 983, entitled "An act establishing a Legislative Finance Bureau; defining its powers and duties, and providing for the election and removal of a director by the General Assembly; authorizing the employment of assistants; imposing certain duties and responsibilities upon the departments, boards and commissions of the State government, and upon agencies receiving State appropriations."

House Bill No. 1926, entitled "An act requiring the Auditor General to make reports to the General Assembly with respect to his audits and the financial affairs of the State Government."

Senate Bill No. 780, entitled "An act for the relief of persons in charge of parades, funeral processions and corteges from liability for injuries, death and loss suffered by guests or persons participating in such parades, funeral processions and corteges, except in certain cases."

Senate Bill No. 395, entitled "An act to amend paragraph nineteen as amended of section one thousand two hundred and ten of the act, approved the eighteenth day of May, one thousand nine hundred and eleven (Pamphlet Laws, three hundred nine), entitled 'An act to establish a public school system in the Commonwealth of Pennsylvania, together with the provisions by which it shall be administered,

and prescribing penalties for the violation thereof; providing revenue to establish and maintain the same, and the method of collecting such revenue; and repealing all laws, general, special or local, or any parts thereof, that are or may be inconsistent therewith,' increasing the amount to be paid by the Commonwealth to school districts of the second and third class in certain cases."

Senate Bill No. 418, entitled "An act permitting courts of this Commonwealth which granted support or alimony to wives in divorce proceedings, under the provisions of clause three, section one of the act, approved the eighth day of May, one thousand eight hundred and fifty-four (Pamphlet Laws, six hundred forty-four), entitled 'A further supplement to the act entitled "An act concerning Divorces,"' as amended, to revoke, annul, or amend such order after investigation."

Senate Bill No. 657, entitled "An act providing a penalty for the unauthorized printing, publishing, sale, distribution, or circulation of copyrighted musical compositions."

House Bill No. 429, entitled "An act relating to the issuance of search warrants; imposing duties on aldermen, justices of the peace and magistrates in relation thereto; and prescribing the form thereof."

House Bill No. 435, entitled "An act relating to the service of search warrants; defining the rights of officers therein, and the time thereof."

House Bill No. 46, entitled "An act to repeal the act, approved the ninth day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand six hundred eighty-four), entitled 'An act authorizing and empowering the county treasurers of the several counties of this Commonwealth to sell at public sale all seated lands upon which taxes assessed on such seated lands by authority of any county, borough, town, township, school district, and poor district are delinquent and remain unpaid, and fixing penalties for such delinquency; authorizing county commissioners to purchase such lands under certain circumstances.'"

House Bill No. 1520, entitled "An act to provide for two additional law judges of the court of common pleas of the thirty-second judicial district."

House Bill No. 639, entitled "A joint resolution creating a commission to act with a similar commission of the State of New Jersey with respect to the construction of a tunnel beneath the Delaware River; and making an appropriation."

House Bill No. 1123, entitled "A joint resolution creating a commission to codify and revise the laws relating to corporations; and making an appropriation."

House Bill No. 927, entitled "An act to amend subheading (a) two of section five hundred and five, article five of the act, approved the ninth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, three hundred forty-three), entitled 'An act relating to the finances of the State Government; providing for the settlement, assessment, collection, and lien of taxes, bonus, and all other accounts due the Commonwealth, the collection and recovery of fees and other money or property due or belonging to the Commonwealth, or any agency thereof, including escheated property and the proceeds of its sale, the custody and disbursement or other disposition of funds and

securities belonging to or in the possession of the Commonwealth, and the settlement of claims against the Commonwealth, the resettlement of accounts and appeals to the courts, refunds of moneys erroneously paid to the Commonwealth, auditing the accounts of the Commonwealth and all agencies thereof of all public officers collecting moneys payable to the Commonwealth or any agency thereof, and all receipts of appropriations from the Commonwealth and imposing penalties; affecting every department, board, commission, and officer of the State government, every political subdivision of the State, and certain officers of such subdivisions, every person, association, and corporation required to pay, assess, or collect taxes, or to make returns or reports under the laws imposing taxes for State purposes, or to pay license fees or other moneys to the Commonwealth, or any agency thereof, every State depository and every debtor or creditor of the Commonwealth,' changing the provisions in relation to the security to be given for the deposit of State moneys."

House Bill No. 844, entitled "An act to amend section four hundred and nine of the act, approved the ninth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, one hundred seventy-seven), entitled 'An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards, and commissions shall be determined,' regulating appointments to the Pennsylvania State Board of Censors."

House Bill No. 540, entitled "An act to amend section two thousand four hundred ten of the act, approved the ninth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, one hundred seventy-seven), entitled 'An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain

departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards, and commissions shall be determined,' by authorizing the Department of Property and Supplies to require certain equipment qualifications of bidders for printing contracts."

House Bill No. 832, entitled "An act to amend section one thousand four hundred and seven of the act, approved the ninth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, one hundred seventy-seven), entitled 'An act providing for and reorganizing the conduct of executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards, and commissions shall be determined,' by authorizing the Armory Board to purchase armories heretofore erected for use of the National Guard, and to acquire, by gift, devise or bequest, lands for armory purposes."

House Bill No. 1653, entitled "An act to further amend the act, approved the twenty-second day of March, one thousand eight hundred and sixty-two (Pamphlet Laws, one hundred sixty-four), entitled 'An act to provide for the destruction and to prevent the spread of Canada Thistles,' by changing penalties provided therein."

Senate Bill No. 117, entitled "An act authorizing the county commissioners of any county to erect and provide for the management of a building or buildings for general hospital purposes and/or for the care and treatment of communicable diseases, to acquire, by purchase, gift, condemnation, or otherwise, a site therefor."

Senate Bill No. 1066, entitled "An act to amend section one hundred eighty-eight of the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand two hundred seventy-eight), entitled 'An act relating to counties of the second, third, fourth, fifth, sixth, seventh and eighth classes; and revising, amending, and consolidating the laws relating thereto,' by changing the method of fixing the salary of the solicitor to the sheriff in counties of the fourth class."

House Bill No. 35, entitled "An act to amend section one of the act, approved the seventeenth day of March, one thousand nine hundred and twenty-one (Pamphlet Laws, thirty-two), entitled 'An act fixing the salaries of court criers and tipstaves in counties of the third class,' by increasing the salaries of said court criers and tipstaves."

House Bill No. 1196, entitled "An act to amend sections seven hundred and sixteen and seven hundred and seventeen of the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand two hundred seventy-eight), entitled 'An act relating to counties of the second, third, fourth, fifth, sixth, seventh and eighth classes; and revising, amending, and consolidating the laws relating thereto,' extending the powers of county commissioners with respect to the alteration and control of streams."

House Bill No. 1593, entitled "An act to amend section fifty-one of the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand two hundred seventy-eight), entitled 'An act relating to counties of the second, third, fourth, fifth, sixth, seventh and eighth classes; and revising, amending, and consolidating the laws relating thereto,' by providing for election of officers when officers elected fail to qualify or when no officer is elected."

House Bill No. 1216, entitled "An act fixing the salary of the recorder of deeds in counties of the third class."

House Bill No. 1138, entitled "An act fixing the compensation to be paid probation officers appointed by the several courts of quarter sessions of counties of the third and fourth classes under the provision of an act, approved the twenty-third day of April, one thousand nine hundred and three (Pamphlet Laws, two hundred seventy-four), entitled 'An act defining the powers of the several courts of quarter sessions of the peace within this Commonwealth with reference to the care, treatment, and control of dependent, neglected, incorrigible, and delinquent children under the age of sixteen years; and providing for the means in which such power may be exercised,' and the supplements and amendments thereto."

Senate Bill No. 708, entitled "An act to provide for the appointment of clerks and stenographers in the office of the district attorney in counties of the third class; and providing for their salaries payable by the county."

Senate Bill No. 4, entitled "An act requiring the county controller, except in counties of the first class, or county auditors to make a monthly audit of the accounts of probation and parole officers, and to report the result of said audits to the court which appointed said probation and parole officers; and fix the compensation of the controller in certain counties for auditing such accounts."

House Bill No. 1777, entitled "An act to amend section one of the act, approved the third day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, one hundred twenty-seven), entitled 'An act fixing the fees of the recorder of deeds in counties of the third and fourth class,' by fixing the fee of the recorder for taking acknowledgments."

House Bill No. 1722, entitled "An act to amend section four hundred and forty-one of the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand two hundred seventy-eight), entitled 'An act relating to counties of the second, third, fourth, fifth, sixth, seventh and eighth classes; and revising, amending, and consolidating the laws relating thereto,' by empowering county commissioners to make appropriations to support children's homes."

House Bill No. 1750, entitled "An act providing for the employment of additional assistant district attorneys in counties of the third class by authority of the salary board, with the approval of the court, in case of emergency or increased business or unusual circumstances or conditions; and providing the salaries thereof."

House Bill No. 23, entitled "An act to amend section two hundred and twenty-four of the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand two hundred seventy-eight), entitled 'An act relating to counties of the second, third, fourth, fifth, sixth, seventh and eighth classes; and revising, amending, and consolidating the laws relating thereto,' by eliminating the requirement that the first deputy prothonotary in counties of the third class shall be learned in the law."

Senate Bill No. 770, entitled "An act to amend the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand two hundred seventy-eight), entitled 'An act relating to counties of the second, third, fourth, fifth, sixth, seventh and eighth classes; and revising, amending, and consolidating the laws relating thereto,' by adding thereto section four hundred thirty-three, authorizing counties of the third and fourth classes to make annual appropriations to combined organizations for Armistice Day purposes."

Senate Bill No. 706, entitled "An act fixing the salaries of the district attorneys in counties of the third class."

House Bill No. 1771, entitled "An act to amend paragraph (c) of section seven of the act, approved the fifth day of May, one thousand nine hundred and eleven (Pamphlet Laws, one hundred ninety-eight), entitled 'An act to establish a county court for the county of Allegheny, and prescribing its powers and duties; regulating the procedure therein; and providing for the expenses thereof,' as amended, permitting cross suits in actions of trespass, and regulating the practice in such cases."

House Bill No. 1473, entitled "An act to amend sections ten, twenty-five, twenty-six, twenty-eight, twenty-nine and thirty-eight of the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand two hundred thirty-seven), entitled 'An act affecting marital relations; prescribing grounds and regulating proceedings for divorce and the annulment of bigamous marriages; and amending, revising, and consolidating the law relating thereto,' clarifying the ground for divorce where the respondent has been convicted of certain crimes; providing for the amendment of libels to include additional grounds for divorce; dispensing with the necessity of an alias subpoena where the respondent cannot be found; and providing for service of notice of hearing on correspondents, and the return of subpoenas."

Senate Bill No. 1016, entitled "An act creating a commission to study the law relating to the Department of Insurance and the business of insurance, and to draft new laws as may appear necessary; and making an appropriation."

Senate Bill No. 1049, entitled "An act providing for the fixing of the salary of the clerk to the jury board in counties of the third class by the salary board."

House Bill No. 1619, entitled "An act to amend section two of the

act, approved the twenty-seventh day of April, one thousand nine hundred and twenty-seven (Pamphlet Laws, four hundred sixty-five), entitled 'An act to provide for the safety of persons employed, housed, or assembled in certain buildings and structures not in cities of the first class, second class and second class A, by requiring certain construction and ways of egress, equipment, and maintenance; providing for the licensing of projectionists; requiring the submission of plans for examination and approval; providing for the promulgation of rules and regulations for the enforcement of this act; providing for the enforcement of this act by the Department of Labor and Industry and, in certain cases, by the chiefs of fire departments in cities of the third class; providing penalties for violations of the provisions of this act; and repealing certain acts,' as amended, by exempting State owned armories used by the Pennsylvania National Guard from the provisions of said act."

Senate Bill No. 324, entitled "An act defining and regulating the practice of chiropraxy; requiring the registration and licensure of persons engaging in such practice; conferring powers and duties upon the Department of Public Instruction; and providing penalties."

Senate Bill No. 873, entitled "An act to amend section four hundred and four of article four of the act, approved the seventeenth day of May, one thousand nine hundred and twenty-one (Pamphlet Laws, six hundred eighty-two), entitled, 'An act relating to insurance; amending, revising, and consolidating the law providing for the incorporation of insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds associations, reciprocal and inter-insurance exchanges, and fire insurance rating bureaus, and the regulation and supervision of insurance carried by such companies, associations, and exchanges, including insurance carried by the State Workmen's Insurance Fund; providing penalties; and repealing existing laws.'"

Senate Bill No. 1048, entitled "An act to amend sections five, six, and seven of the act, approved the twentieth day of May, one thousand nine hundred and twenty-one (Pamphlet Laws, nine hundred sixteen), entitled 'An act defining fraternal benefit societies and their status; authorizing such societies to create subordinate lodges, and to pay benefits to members and their beneficiaries from funds collected, and regulating such benefits and collections; providing for the organization and incorporation of such societies, and for their supervision, regulation, and examination by the Insurance Commissioner, and for the admission of foreign societies; designating tables of mortality as a basis for rates of contribution; requiring all societies to make annual and other reports, and appointing the Insurance Commissioner as attorney for service of process; providing penalties for any violations of the act; exempting such societies from taxation and certain other societies from its provisions; and requiring beneficial associations, other than fraternal benefit societies, to report to, and be supervised by, the Insurance Commissioner; and repealing existing laws,' by eliminating conflicting provisions relating to benefits; prescribing who may become members and beneficiaries, and the rights of members and beneficiaries; and eliminating the necessity of examination by physicians."

Senate Bill No. 891, entitled "An act to amend an act, approved

the twenty-third day of April, one thousand nine hundred and nine (Pamphlet Laws, one hundred seventy-one), entitled 'An act making it a misdemeanor for any person to make, utter, circulate, or transmit false or derogatory statements affecting the solvency or financial standing of any bank, banking house, banking company, trust company, surety company, guarantee company, title insurance company, or other financial institution in this Commonwealth; and providing penalties for violation of this act,' by extending the provisions of the act to national banks and building and loan associations."

Senate Bill No. 1019, entitled "An act to amend section five hundred seventeen of the act, approved the seventeenth day of May, one thousand nine hundred and twenty-one (Pamphlet Laws, six hundred eighty-two), entitled 'An act relating to insurance; amending, revising, and consolidating the law providing for the incorporation of insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds associations, reciprocal and inter-insurance exchanges, and fire insurance rating bureaus, and the regulation and supervision of insurance carried by such companies, associations, and exchanges, including insurance carried by the State Workmen's Insurance Fund; providing penalties; and repealing existing laws,' by authorizing the capital of any stock fire, stock marine, or stock fire and marine insurance company of this Commonwealth to be invested in bonds or notes of any solvent public utility."

Senate Bill No. 85, entitled "An act providing that the chairmen of the respective appropriation committees of the House of Representatives and Senate shall collaborate with, assist, and advise the budget secretary in the preparation of budget information to be submitted to the Governor, and shall assist the Governor in the revision thereof; and making an allowance for the payment of the expenses of said chairmen."

Senate Bill No. 507, entitled "An act requiring the Department of Revenue to prepare and distribute lists of stocks and securities exempt from the city and county tax on intangible personal property."

House Bill No. 1932, entitled "An act to amend section seven of the act, approved the fifth day of May, one thousand nine hundred and twenty-one (Pamphlet Laws, three hundred ninety-nine), entitled 'An act regulating and defining the powers and duties of the Dental Council and the State Board of Dental Examiners; providing for appointment of examiners; defining qualifications of applicants for examination; condition of granting and revoking licenses; regulating and limiting and defining the practice of dentistry; limiting and defining operator in dental surgery; prohibiting practice by or employment of unlicensed and unregistered persons, and providing punishment therefor; requiring the recording of licenses and registration of practitioners and disposition of fees and fines; providing for an annual registration fee for licensed practitioners and the disposition of such fees; defining evidence of violations and providing punishment; fixing the appropriations to the Dental Council,' by prohibiting certain forms of advertising by persons practicing dentistry."

Senate Bill No. 186, entitled "An act creating a commission to make a study of local government and report thereon."

House Bill No. 635, entitled "An act requiring the sheriff to give



the purchaser at any sheriff's sale of real estate a certificate of the nature of the proceedings for service on any occupant of the premises advertised to be sold; and fixing the fee for making such certificate."

Senate Bill No. 916, entitled "An act to amend section two of the act, approved the thirtieth day of January, one thousand eight hundred and seventy-four (Pamphlet Laws, thirty-one), entitled 'A further supplement to the act regulating elections in this Commonwealth' as amended, increasing the number of days the registry assessors in counties of the second class have for making their assessments."

Senate Bill No. 963, entitled "An act to amend section five hundred twelve of the act, approved the ninth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, one hundred seventy-seven), entitled 'An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards, and commissions shall be determined,' by providing that the Auditor General shall not be required or be forced to follow the legal advice of the Department of Justice."

Senate Bill No. 919, entitled "A supplement to an act, approved the seventh day of March, one thousand nine hundred and one (Pamphlet Laws, twenty), entitled 'An act for the government of cities of the second class,' by providing for the appointment of a solicitor as attorney and legal advisor for the Department of City Controller."

House Bill No. 1613, entitled "An act providing for preference to citizens of this Commonwealth in employment upon public works of this Commonwealth; conferring certain duties on the Department of Labor and Industry; and providing penalties."

House Bill No. 83, entitled "An act relating to the employment of persons in the service of the Commonwealth."

House Bill No. 1901, entitled "An act authorizing the Board of Finance and Revenue in certain cases to refund or credit penalties imposed."

House Bill No. 145, entitled "An Act to amend subsection ninth of section one of the act, approved the ninth day of July, one thousand nine hundred and one (Pamphlet Laws, six hundred fourteen), entitled 'An act relating to the service of certain process in actions at law, and the effect thereof; and providing who shall be made parties to certain writs,' providing a method of service of a writ of replevin when the defendant cannot be served in the county and no one is in possession of the goods and chattels."

Senate Bill No. 993, entitled "An act to regulate procedure for the more expeditious administration of justice and to avoid circuitry of action where it is desired, after the institution of a suit at law, to have joined, as additional defendants, persons or corporations who it is alleged are liable over to or jointly liable with a defendant of record, or severally liable to the plaintiff or to some other party of record, with respect to the transaction or occurrence upon which the suit is based, with provision as to the effect of the act upon the statute of limitations; and repealing the act of April tenth, one thousand nine hundred and twenty-nine (Pamphlet Laws, four hundred seventy-nine), and inconsistent legislation."

Senate Bill No. 398, entitled "An act providing for the assessment by the board of assessment and revision of taxes, in counties of the second and third classes, of persons subject to the county poll tax, not theretofore assessed, at any time more than two months prior to any election."

House Bill No. 1223, entitled "An act to amend an act, approved the tenth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, four hundred seventy-nine), entitled 'An act to regulate procedure where a defendant desires to have joined, as additional defendants, persons whom he alleges are liable over to him or jointly or severally liable with him for the cause of action declared on.'"

House Bill No. 320, entitled "An act to amend sections one and four of the act, approved the eighth day of July, one thousand eight hundred and eighty-five (Pamphlet Laws, two hundred sixty-eight), entitled 'An act relative to the purchase of lands by county commissioners at sales thereof for arrearages of taxes,' by providing circumstances under which a county shall be deemed to have abandoned title to lands purchased at a county treasurer's sale; and fixing the time within which a county commissioner's sale must be held."

Senate Bill No. 778, entitled "An act making an appropriation to the Spring Garden Institute, Broad and Spring Garden Streets, Philadelphia, Pennsylvania."

House Bill No. 1132, entitled "An act making an appropriation to the Department of Property and Supplies for the erection of an additional office building in Capitol Park, and for grading and terracing the ground surrounding the same."

House Bill No. 1314, entitled "An act making an appropriation to the Department of Property and Supplies to provide and erect a bronze replica of a statue of George Washington."

House Bill No. 1513, entitled "An act making an appropriation to the Department of Forests and Waters for the acquisition of lands for State forests."

House Bill No. 1604, entitled "An act making an appropriation to the Buena Vista Park Association for the purpose of securing, restoring, and preserving the Buena Vista Charcoal Furnace in Brush Valley Township, Indiana County."

State Highway Commissioner to make maps to be complete records thereof; conferring authority on the State Highway Commissioner; providing for the payment of damages in taking of property, or otherwise, in the improvement thereof; providing for purchase or acquiring of turnpikes or toll-roads forming all or part of any State Highway, and procedure therein; providing for work of improvement of State Highways to be done by contract, except where the State Highway Commissioner decides the work be done by the State; providing aid by the State to counties and townships desiring the same in the improvement of township or county roads; defining highways and State-aid highways; providing method of application for State aid in the improvement, maintenance, and repair of township or county roads and prescribing the contents of township, county, borough, or incorporated town petitions; providing for percentage of cost of improvement or repairs to be paid by State, county, township, borough, or incorporated town, and requiring contracts by counties, townships, boroughs, and incorporated towns with Commonwealth governing same; providing for the minimum width of State Highways and State-aid highways, and kind of materials to be used in the improvement; providing for payment of cost of improvement and repairs; providing penalty for injuring or destroying State Highways; making appropriations to carry out the provisions of the act; and providing for the repeal of certain acts relating to Highway Department and improvement of roads, and of all acts or parts of acts inconsistent herewith; and providing that existing contracts are not affected by provisions of this act,' as amended, providing for the division of the damages caused by change of width or location of State highways between the Commonwealth and counties."

House Bill No. 53, entitled "An act to amend section four hundred thirty-four of the act, approved the fourteenth day of July, one thousand nine hundred and seventeen (Pamphlet Laws, eight hundred forty), entitled 'An act concerning townships; and revising, amending, and consolidating the law relating thereto,' as amended, changing the rates of payments of township rewards by the Commonwealth."

Senate Bill No. 1057, entitled "A further supplement to an act, approved the twenty-eighth day of April, one thousand nine hundred and three, entitled 'An act for the annexation of any city, borough, township, or part of a township, to a contiguous city; and providing for the indebtedness of the same,' and the supplements and amendments thereto; providing that the council of the city to which said territory is annexed may validate as legal indebtedness of the enlarged city certain indebtedness, theretofore authorized by the councils or commissioners of the territory annexed, which exceeds two per centum of the assessed value of the taxable property therein and which might have been ratified by the electors of such territory so annexed."

House Bill No. 1411, entitled "An act to amend section twenty-one of the act, approved seventh day of June, one thousand nine hundred and fifteen (Pamphlet Laws, nine hundred), entitled 'An act to provide for the immediate registration of all births and deaths throughout the Commonwealth of Pennsylvania, by means of certificates of births and deaths, and burial or removal permits; requiring prompt returns to the Central Bureau of Vital Statistics, as required to be established by the State Department of Health; and, in order to se-

cure prompt and faithful registration of births, marriages, deaths, and diseases, of practitioners of medicine and surgery, of midwives, nurses, and undertakers, and of all persons whose occupation is deemed to be of importance in obtaining complete registration of births, deaths, marriages, and diseases throughout the State, as provided in section ten of an act, entitled "An act creating the Department of Health and defining its powers and duties," approved the twenty-seventh day of April, nineteen hundred and five; and providing penalties for violations of this act,' as amended, providing that certified copies of death certificates shall not be prima facie evidence of the cause of death."

House Bill No. 1865, entitled "An act making it unlawful to fumigate any apartment house with poisonous gases without first giving notice thereof to tenants and occupants; and providing penalties."

Senate Bill No. 26, entitled "An act to amend section six hundred nineteen of the act, approved the first day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, nine hundred five), entitled 'An act for the protection of the public safety; regulating the use of highways and the operation of vehicles, tractors, street cars, trackless trolley, omnibuses, bicycles, pedestrians, and the riding of animals upon the highways of this Commonwealth; providing for the titling, including liens, encumbrances, and legal claims, registration of certain vehicles, and licensing the operators thereof, upon payment of prescribed fees; prescribing and limiting the powers of local authorities to deal with the subject matter of this act; conferring powers and imposing duties upon the Department of Revenue, the Department of Highways, peace officers, mayors, burgesses, magistrates, aldermen, justices of the peace, the courts and the clerks thereof, owners of vehicles, and garage keepers; providing that records are admissible as evidence; imposing upon owners, counties, cities, boroughs, incorporated towns, townships, within the Commonwealth, liability for damages caused by the negligent operation of their motor vehicles; imposing penalties; imposing certain costs upon counties; providing for the disposition of fines, forfeitures, fees, and miscellaneous receipts; making an appropriation; and providing for refunds,' by making municipalities liable for negligence of drivers of motor vehicles belonging to volunteer fire companies."

House Bill No. 896, entitled "An act to amend the act, approved the sixteenth day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand seven hundred eighty), entitled 'An act providing for the taking over as State highways by the State of certain State-aid highways and township reward roads; and requiring the maintenance and reconstruction thereof by the Department of Highways,' by extending provisions of act to all township roads constructed of reinforced concrete."

House Bill No. 278, entitled "An act to amend section one of the act, approved the sixteenth day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, seventeen hundred eighty), entitled 'An act providing for the taking over as State Highways by the State of certain State-aid highways and township reward roads; and requiring the maintenance and reconstruction thereof by the Department of Highways,' by providing for the taking over of all State-aid highways by the State when constructed or improved."

Senate Bill No. 44, entitled "An act providing for the taking over by the Commonwealth of certain State-aid highways as State highways."

House Bill No. 853, entitled "An act to amend section one of the act, approved the sixteenth day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand seven hundred eighty), entitled 'An act providing for the taking over as State Highways by the State of certain State-aid highways and township reward roads; and requiring the maintenance and reconstruction thereof by the Department of Highways,' providing for the taking over of State-aid highways in boroughs and all State-aid highways and township reward concrete roads hereafter constructed."

House Bill No. 1647, entitled "An act to amend section one of the act, approved the seventeenth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, five hundred thirty), entitled 'An act authorizing the retention of the route of any vacated public road, or portion thereof, as a private road,' reserving such roads also for the use of the Department of Forests and Waters or the Board of Game Commissioners, and reserving roads vacated by road commissioners for the same purposes."

Senate Bill No. 727, entitled "An act to preserve historical sites within the Commonwealth by providing that they shall not be subject to be taken by condemnation in the exercise of the right of eminent domain."

House Bill No. 1441, entitled "An act to amend section sixty-two of the act, approved the sixteenth day of June, one thousand eight hundred and thirty-six (Pamphlet Laws, seven hundred fifty-five), entitled 'An act relating to executions,' by providing for the service upon defendant of notice of sale of real estate under writ of venditioni exponas."

Senate Bill No. 668, entitled "An act to amend sections seven and eight of the act, approved the thirty-first day of March, one thousand eight hundred and seventy-six (Pamphlet Laws, thirteen), entitled 'An act to carry into effect section five of article fourteen of the constitution relative to the salaries of county officers, and the payment of fees received by them into the State or county treasury in counties containing over one hundred and fifty thousand inhabitants,' by empowering the salary board to allow additional employes for the county controller, and fix their salaries."

House Bill No. 622, entitled "An act requiring certain materials and work required by cities of the third class to be performed under contract to be awarded to the lowest bidder, and providing exceptions."

Senate Bill No. 647, entitled "An act to amend section three of the act, approved the twenty-eighth day of June, one thousand nine hundred seventeen (Pamphlet Laws, six hundred forty-five), entitled 'An act making it unlawful for any individual or individuals to carry on or conduct any business under an assumed or fictitious name, style, or designation, unless upon the filing of a certificate to that effect in the office of the Secretary of the Commonwealth and of the prothonotary; requiring county commissioners, at the expense of the county to provide books for the entry of such certificates; fixing the fees of the Secretary of the Commonwealth and prothonotary; and providing penalties,' changing the penalty to a summary proceeding; and provid-

ing for the enforcement of this act by the Secretary of the Commonwealth."

House Bill No. 1906, entitled "An act making an appropriation to the Board of Trustees of the Harrisburg State Hospital for fences, and for the stewards' house."

Senate Bill No. 1267, entitled "An act making an appropriation to the Pennsylvania State College for research in grasses."

Senate Bill No. 1275, entitled "An act granting a pension for military service to Robert R. Hoffman, of county of Lehigh."

House Bill No. 1475, entitled "An act to amend section fourteen of the act, approved the eighteenth day of July, one thousand nine hundred and seventeen (Pamphlet Laws, one thousand forty-three), entitled 'An act establishing a public school employes' retirement system, and creating a retirement board for the administration thereof; establishing certain funds from contributions by the Commonwealth and contributing employes; defining the uses and purposes thereof and the manner of payment therefrom, and providing for the guaranty by the Commonwealth of certain of said funds; imposing powers and duties upon boards having the employment of public school employes; exempting annuities, allowances, returns, benefits, and rights from taxation and judicial process; and providing penalties,' as amended,



providing for the continuation in service of school superintendents in certain cases."

House Bill No. 1420, entitled "An act providing for the discharge or parole of persons serving imprisonment for failure to make restitution under sentence of any court."

House Bill No. 1089, entitled "An act relating to criminal procedure; imposing upon officers conducting preliminary hearings the duty of obtaining names of persons whom defendants desire notified of time of trial; and imposing upon the district attorney the duty of notifying such persons thereof."

House Bill No. 469, entitled "An act to amend section three of the act, approved the seventh day of June, one thousand nine hundred and seventeen (Pamphlet Laws, four hundred twenty-nine), entitled 'An act relating to the descent and distribution of the real and personal property of persons dying intestate, and to provide for the recording and registering of the decrees of the orphan's court in connection therewith and the fees therefor,' by permitting use of home by widow for period of four months following death of husband."

House Bill No. 470, entitled "An act to amend section twelve of the act, approved the seventh day of June, one thousand nine hundred and seventeen (Pamphlet Laws, four hundred three), entitled 'An act relating to the form, execution, revocation, and interpretation of wills; to nuncupative wills; to the appointment of testamentary guardians; to spendthrift trusts; to forfeiture of devise or legacy in case of murder of testator; to elections to take under or against wills, and to the recording and registering of such elections and of decrees relative thereto, and to the fees therefor,' by providing that any devise of real estate used as a home shall be subject to the right of the widow of testator to occupy the same for a period of four months following death of testator."

Senate Bill No. 566, entitled "A further supplement to an act, approved the ninth day of April, one thousand eight hundred and sixty-two (Pamphlet Laws, three hundred fifty-two), entitled 'An act to authorize the erection of a poor house by the borough of Dunmore, borough of Scranton, and township of Providence, in the county of Luzerne,' requiring the county commissioners of Lackawanna county, upon the requisition of the poor directors of such district, to levy and collect the poor taxes therefor."

House Bill No. 1430, entitled "An act providing for assistance by the Commonwealth in the improvement, construction, reconstruction, and/or maintenance of certain streets and highways in boroughs, and for the assessment of benefits against owners of real estate abutting on the line of the improvement; and making an appropriation."

House Bill No. 679, entitled "An act concerning townships of the second class; and amending, revising, consolidating, and changing the law relating thereto."

Senate Bill No. 1013, entitled "An act prohibiting the killing, wounding, capturing, or hunting of foxes by certain methods in the counties of Delaware, Chester, Montgomery, Berks, Lancaster, Westmoreland, and Allegheny; making the possession of a fox or fox hide prima facie evidence of a violation; and fixing penalties."

Senate Bill No. 1014, entitled "An act providing for the licensing by the State of persons engaging in the sport of fox hunting in the

counties of Delaware, Chester, Montgomery, Berks, Lancaster, Westmoreland, and Allegheny; providing for the appointment of inspectors and of all other acts for the protection of foxes; appropriating moneys received; and prescribing penalties."

Senate Bill No. 643, entitled "An act to amend the title and section one of the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, twelve hundred and seventy-eight), entitled 'An act authorizing county commissioners to appropriate moneys to cities, boroughs, towns, and townships to assist in the acquisition, operation, and maintenance of airdromes and aviation landing fields,' by authorizing and empowering county commissioners to appropriate moneys to cities, boroughs, towns, townships, corporations or individuals to assist in the acquisition, operation, and maintenance of airports, airdromes, and aviation landing fields within such county or within any adjacent county."

Senate Bill No. 645, entitled "An act authorizing and empowering incorporated towns, townships, and other political subdivisions of this Commonwealth to establish, maintain, and operate airports, airdromes, landing fields, intermediate landing fields, and air navigation facilities; authorizing and empowering incorporated towns, townships, and other political subdivisions of this Commonwealth to acquire, by lease or purchase, any land within or without the limits of said incorporated towns, townships, and other political subdivisions for aviation purposes; authorizing the lease by the said parts thereof to individuals or corporations, and the lease thereof to the Government of the United States upon nominal rent; and empowering said incorporated towns, townships the same for aviation purposes jointly with any county, city, incorporated town, borough, township, or political subdivision; authorizing and empowering said incorporated towns, townships, and other political subdivisions to incur indebtedness and issue bonds for acquisition, construction, completion, operation, or maintenance of airports, landing fields, air navigation facilities, or lands for any of the purposes mentioned in this act; and repealing inconsistent legislation."

House Bill No. 933, entitled "An act making an appropriation from the general fund to the Department of Highways for the purpose of rebuilding a county bridge, in Armstrong County, destroyed by flood."

House Bill No. 1299, entitled "An act to validate acts done and contracts, conveyances, transfers, and mortgages of property made to or by any corporation of the first class created or intended to be created by decree of the courts of common pleas, granting a charter where the applicants for incorporation had failed to register its proposed name at the time of filing their applications, and prior to the advertisement as required by law, but did so before the charter was granted; and to validate charters of corporations of the first class granted since the sixteenth day of May, one thousand nine hundred and twenty-three, where the applicants for incorporation had failed to register its proposed name at the time of filing their applications and prior to the advertisement as required by law, but did so before the charter was granted."

House Bill No. 133, entitled "An act validating the title to real estate purchased at a judicial sale for unpaid taxes or municipal assessments, pursuant to the provisions of an act, approved the six-

teenth day of May, one thousand nine hundred and twenty-three (Pamphlet Laws, two hundred seven), entitled 'An act providing when, how, upon what property, and to what extent, liens shall be allowed for taxes and for municipal improvements, for the removal of nuisances, and for the water rents or rates, sewer rates, and lighting rates; for the procedure upon claims filed therefor; the methods for preserving such liens and enforcing payment of such claims; the effect of judicial sales of the properties liened; the distribution of the proceeds of such sales, and the redemption of the property therefrom; for the lien and collection of certain taxes heretofore assessed, and of claims for municipal improvements made and nuisances removed, within six months before the passage of this act; and for the procedure on tax and municipal claims filed under other and prior acts of Assembly,' and its amendments."

House Bill No. 1379, entitled "An act validating certain proceedings and elections of counties, cities, boroughs, townships, school districts, and other municipalities or incorporated districts had and held pursuant to the provision of an act, approved the twentieth day of April, one thousand eight hundred and seventy-four (Pamphlet Laws, sixty-five), entitled 'An act to regulate the manner of increasing the indebtedness of municipalities, to provide for the redemption of the same, and to impose penalties for the illegal increase thereof,' and the amendments and supplements thereto, and validating bonds issued or authorized to be issued in pursuance of such proceedings and elections."

House Bill No. 993, entitled "An act providing the manner in which boroughs and townships of the first class may secure the service of members of the State Police force; providing for their payment, maintenance, and discipline, and for their powers and duties; and providing for the appointment of a reserve force."

Senate Bill No. 509, entitled "An act authorizing George E. Kirschner and Joseph F. Kirschner, co-partners, doing business under the firm name and style of Kirschner Brothers, citizens of the city of Erie, Pennsylvania, to bring suit in the court of common pleas of Dauphin County against the Commonwealth of Pennsylvania."

House Bill No. 1135, entitled "A supplement to the act, approved the third day of April, one thousand nine hundred and three (Pamphlet Laws, one hundred thirty-seven), entitled 'An act regulating the confinement of children under the age of sixteen years awaiting trial,' providing for the management of houses of detention for juveniles in counties of the second class; imposing expense in connection therewith on the county; and permitting and authorizing the county commissioners thereof to appropriate money or issue bonds for the purchase of lands, erection and equipping of buildings for such purpose."

House Bill No. 1590, entitled "An act providing for the licensing and regulation of second-hand dealers; imposing duties upon peace officers, district attorneys, and sheriffs; and prescribing penalties."

House Bill No. 1596, entitled "An act authorizing Frederick J. Osterling, Architect, a citizen of the city of Pittsburgh, Pennsylvania, to bring suit in the court of common pleas of Dauphin County against the Commonwealth of Pennsylvania."

House Bill No. 878, entitled "An act to amend section five of the act, approved the eighteenth day of April, one thousand nine hundred

and twenty-nine (Pamphlet Laws, five hundred forty-nine), entitled 'An act to permit the use of voting machines for recording and computing the vote at all elections, including primaries, in any county, city, borough, or township of Commonwealth, at the option of the electors thereof; prescribing regulations with reference to the adoption, requirements, examination, purchase, installation, preparation, custody and demonstration of use of voting machines; providing rules and regulations for the conduct of elections held with voting machines; prescribing the qualifications, number and duties of election officers in election districts in which voting machines may be used; placing duties upon county commissioners and the Secretary of the Commonwealth; providing for redivision of wards of cities and boroughs into election districts, and the consolidation of election districts; providing for the payment of expenses incident to the purchase and use of voting machines by the counties in which they are used; and providing penalties for violation of the provisions of this act,' by decreasing the number of voters to one election district."

House Bill No. 863, entitled "An act making an appropriation to the Trustees of the University of Pittsburgh for the maintenance of the Falk Clinic of the University of Pittsburgh, including instruction of students in the School of Medicine of the University in the departments of the Falk Clinic not included in the instruction given in hospitals."

House Bill No. 1594, entitled "An act making an appropriation to pay for work done and services rendered by the architect in furnishing plans and specifications of buildings for the State Institution for Feeble Minded at Polk, Pennsylvania."

Senate Bill No. 15, entitled "An act to amend section two of the act, approved the twenty-seventh day of April, one thousand nine hundred and twenty-seven (Pamphlet Laws, three hundred ninety-five), entitled 'An act empowering the Department of Highways to acquire certain toll bridges within the Commonwealth; providing the procedure therefor; providing for the reimbursement of the Commonwealth from tolls and charges; and making an appropriation,' eliminating the proviso which restricts the acquisition of toll bridges until moneys are provided by constitutional amendment."

Senate Bill No. 776, entitled "An act to amend sections five hundred and one, five hundred and two, and five hundred and nine as amended, and seven hundred and four (b), seven hundred and five, seven hundred and six, and seven hundred and seven, and to repeal section five hundred and eleven, of the act, approved the twenty-fourth day of May, one thousand nine hundred and twenty-three (Pamphlet Laws, three hundred fifty-nine), entitled 'An act concerning game and other wild birds and wild animals; and amending, revising, consolidating, and changing the law relating thereto,' by declaring an open season for deer without visible antlers over a certain weight; authorizing the Board of Game Commissioners to reduce or close seasons for either sex of game animals or birds; fixing the open season for raccoon; and permitting the hunting of elk, deer, and bear by the use of a bow and arrow."

Senate Bill No. 77, entitled "An act making an appropriation to the Pennsylvania Historical Commission for the purpose of reimbursing

the Conrad Weiser Memorial for moneys expended in maintaining Conrad Weiser Memorial Park until accepted by the Commonwealth."

Senate Bill No. 168, entitled "An act authorizing the commission appointed pursuant to the provisions of the act, approved the eighth day of May, one thousand nine hundred and nineteen (Pamphlet Laws, one hundred forty-eight), entitled 'An act providing for the joint acquisition and maintenance by the Commonwealth of Pennsylvania and the State of New Jersey of certain toll bridges over the Delaware River,' and the amendments and supplements thereto, to provide for the construction and maintenance of a free bridge across the Delaware River between Phillipsburg, New Jersey, and Easton, Pennsylvania; and making an appropriation."

Senate Bill No. 969, entitled "An act providing for and making an appropriation to aid in defraying expenses of the National Convention of the Disabled War Veterans, to defray expenses in connection with dedication of Soldiers and Sailors Memorial Bridge at Wilkes-Barre, and providing for payment thereof to the Wyoming Valley Committee in charge of the convention."
