tenced to pay a fine of not more than five hundred dollars (\$500) or to undergo an imprisonment of not more than one year, or both, at the discretion of the court.

Section 9. Constitutionality.—The provisions of this act shall be severable, and if any of the provisions shall be held to be unconstitutional, such decision shall not affect the validity of any of the remaining provisions of this act.

Section 10. Effective Date .- The provisions of this When effective. act shall become effective immediately upon final enactment.

### AN ACT

To amend section one of the act, approved the twenty-ninth day of May, one thousand nine hundred and seventeen (Pamphlet Laws, three hundred twenty-two), entitled "An act to give protection, and to regulate the catching or taking or having in possession, within this Commonwealth, of any bullfrogs, tadpoles, and terrapin; and providing penalties and punishments for violation of any of the provisions of this act, and the manner of proceeding to enforce compliance therewith; and providing for the dispo-sition of the penalties and fines recovered and received; and how, and by whom, the costs in such cases shall be paid," providing penalties for catching or killing bullfrogs, tadpoles, or terrapin out of season.

Section 1. Be it enacted, &c., That section one of the section 1, act of may 29, 1917 (P. L. 322), act, approved the twenty-ninth day of May, one thousand nine hundred and seventeen (Pamphlet Laws, three amended. hundred twenty-two), entitled "An act to give protection, and to regulate the catching or taking or having in possession, within this Commonwealth, of any bullfrogs, tadpoles, and terrapin; and providing penalties and punishments for violation of any of the provisions of this act, and the manner of proceeding to enforce compliance therewith; and providing for the disposition of the penalties and fines recovered and received; and how, and by whom, the costs in such cases shall be paid." is hereby amended to read as follows:

Be it enacted, &c., That from and after the Bullfrogs, tadpoles and terrapin. passage of this act it shall be unlawful for any person to catch, take, or kill any bullfrogs or tadpoles, from the first day of November to the first day of July, both dates close season. inclusive, and terrapin from the fifteenth day of March to the first day of November, both dates inclusive, in each year, in any of the waters within this Commonwealth or in the boundary waters thereof. Any person violating Penalty for the violation of any of the provisions of this section shall, on conviction this section.

# AN ACT

Requiring persons applying for or receiving relief to furnish, under affidavit, certain information, and to sign a bond conditioned on the truthfulness of his statements and the lack of fraud or misrepresentation; empowering certain persons to administer oaths; and prescribing penalties.

Section 1. Be it enacted, &c., That every person, applying for direct relief or work relief from any agency, authorized by law to distribute or furnish such relief out of any moneys appropriated in whole or in part by the Commonwealth or by the Federal Government, and every person now receiving such relief, shall be required to sign a statement, setting forth his or her financial status and such other facts as may be required by the State Emergency Relief Board, in order to determine whether such person is entitled to relief, and shall also be required to sign, as a part of his or her written application, his or her own bond to the Commonwealth, without surety, containing a warrant of attorney to confess judgment in the penal sum of five hundred dollars, which bond shall be conditioned on the truth and lack of fraud and misrepresentation in any of the statements made by such applicant in his or her written application. Every such applicant shall make affidavit that the facts set forth in such statement are true and correct. Any person employed in the distribution of unemployment relief shall have power to administer oaths for the purpose of carrying into effect the provisions of this act.

Section 2. Every person giving any wilfully false information in any such statement shall be guilty of a misdemeanor, and, upon conviction thereof, shall be sentenced to pay a fine of not more than five hundred dollars or suffer imprisonment for not more than six months, or both, in the discretion of the court, and shall also be sentenced to make restitution of any moneys received by reason of any such false statement. In case such moneys are not restored, proceedings may be had on the bond herein provided for.

Section 3. This act shall become effective immediately upon final enactment.
