Section 220. Resident Fishing License Fees.—For the Application purposes of this article, every person sixteen years of age and upward, upon application to any county treasurer within the Commonwealth, or to the Department of Revenue, and the presentation of proof that he has been a bona fide resident of this Commonwealth for a period of thirty days preceding his application and was born in the United States, or was fully naturalized under the laws of the United States, shall, upon the payment to the county treasurer or the Department of Revenue of a license fee of one dollar and fifty cents for the use of the Commonwealth, and, in the event that the license is issued by a county treasurer, a fee of ten cents for the use of the county treasurer, be entitled to the license herein referred to as "a resident fishing license."

cial metal tag, which shall give him the right to use and operate an eel chute in the Susquehanna River [below the northern boundary of Berwick] below the boundary line of the city of Pittston and the Duryea Borough line on the north branch, below the bridge at the Northumberland-Lycoming County line on the west branch, in the Juniata River below Mount Union, and in the Delaware River below Easton, in accordance with the provisions of this act.

## AN ACT

To amend section six of the act, approved the eleventh day of June, one thousand nine hundred and thirty-one (Pamphlet Laws, four hundred ninety-seven), entitled "An act regulating and licensing the sale, transfer, and possession of certain firearms; prescribing penalties, procedure, and rules of evidence; conferring powers and imposing duties on courts of quarter sessions, sheriffs, and heads of police departments; and to make uniform the law with reference thereto," by exempting hunters and fishers, and persons training dogs from the licensure provisions of the act under certain circumstances.

The Uniform Firearms Act.

Section 1. Be it enacted, &c., That section six of the act, approved the eleventh day of June, one thousand nine hundred and thirty-one (Pamphlet Laws, four hundred ninety-seven), entitled "An act regulating and licensing the sale, transfer, and possession of certain firearms; prescribing penalties, procedure, and rules of evidence; conferring powers and imposing duties on courts of quarter sessions, sheriffs, and heads of police departments; and to make uniform the law with reference thereto," is hereby amended to read as follows:

Exceptions.

Section 6. The provisions of the preceding section shall not apply to constables, sheriffs, prison or jail wardens, or their deputies, policemen of the Commonwealth or its political subdivisions, or other law-enforcement officers; or to members of the army, navy or marine corps of the United States or of the national guard or organized reserves when on duty; or to the regularly enrolled members of any organization duly authorized to purchase or receive such weapons from the United States or from this Commonwealth; or any organization incorporated under the laws of this Commonwealth engaged in target shooting with rifle, pistol, or revolver, provided such members are at or are going to or from their places of assembly or target practice, or to officers or employes of the United States duly authorized to carry a concealed firearm, or to agents, messenger and other em-
