AN ACT

Amending the act of May 4, 1927 (P. L. 519), entitled "An act concerning boroughs, and revising, amending, and consolidating the law relating to boroughs," providing for the appointment of special school police, defining their powers and duties, and providing for their compensation by the borough.

The Borough Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Act of May 4, 1927, P. L. 519, reenacted and amended July 10, 1947, P. L. 1621, amended by adding a new section 1129.1.

Section 1. The act of May 4, 1927 (P. L. 519), known as "The Borough Code," reenacted and amended July 10, 1947 (P. L. 1621), is amended by adding, after section 1129, a new section to read:

*Section 1129.1. Special School Police.—Upon request of the board of school directors of the school district of the borough, the borough council may appoint special school police who shall have the duty of controlling and directing traffic at or near schools and who shall be in suitable and distinctive uniform and shall display a badge or other sign of authority. Such police shall be vested with all the power of local police officers and while on duty shall be under and subject to the direction of the chief of police. They shall serve at the pleasure of the borough council and shall not come within the civil service provisions of this act and shall not be entitled to participate in any police pension plan or plans now in effect or hereinafter effective. The compensation of the school police, if any, shall be fixed by the borough council and shall be paid by the borough.*

Act effective immediately.

Section 2. This act shall take effect immediately.

AN ACT

Amending the act of December 15, 1959 (P. L. 1779), entitled "An act relating to fish; and amending, revising, consolidating and changing the law relating to fish in the inland waters and

the boundary lakes and boundary rivers of the Commonwealth," further regulating the issuance of artificial propagation licenses for fish, bait fish and fish bait, and the fees for such licenses; providing for the issuance of such licenses for propagation of frogs, tadpoles and turtles; making special provision for live bait dealers' licenses and transportation permits, and requiring live bait being distributed in the State to be inspected.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The Fish Law  
of 1959.

Section 1. Section 170, act of December 15, 1959 (P. L. 1779), known as "The Fish Law of 1959," is amended to read:

Section 170. Commission May Issue Propagation Licenses.—The Commission is authorized to issue an artificial propagation license for the propagation of all species of trout and all species of bass, upon a written application therefor signed by the applicant and upon the payment to the Commission of the sum of twenty-five dollars (\$25.00), each, for the propagation of trout and of bass; for the propagation of gold fish, the sum of twenty-five dollars (\$25.00) [and]; for each other species of fish, the sum of twenty-five dollars (\$25.00) [ : Provided, That a person licensed to propagate bait fish upon a written application therefor signed by the applicant and upon the payment to the Commission of the sum of ten dollars (\$10.00) for a dealer's license, wholesale or retail, may also propagate and sell fish bait]; and for frogs, tadpoles and turtles, the sum of twenty-five dollars (\$25.00); and for all species of bait fish and fish bait, the sum of twenty-five dollars (\$25.00). A separate propagation license shall be required for each separate propagation plant even though owned and operated by the same individual or corporation.

Section 2. The act is amended by adding, after section 170, a new section to read:

*Section 170.1. Live Bait Dealers' Licenses.—The Commission is authorized to issue live bait fish and live fish bait dealers' licenses upon a written application therefor signed by the applicant and upon the payment to the Commission of the sum of ten dollars (\$10.00). The Commission may issue such a license to persons who do not propagate said bait but who buy and sell live bait. The licensee shall keep records of all transactions, both buying and selling, listing the names and addresses of all customers, the date, number of species sold, and from whom the dealers purchased the live bait, date, species and number purchased.*

*Resident live bait dealers who purchase their bait from legal sources outside of Pennsylvania shall first obtain a transportation permit from the Fish Commis-*

sion at a cost of two dollars (\$2.00) for each permit, and nonresidents who bring live bait into Pennsylvania for sale shall first secure a nonresident bait dealers license at a cost of one hundred dollars (\$100.00) per year.

No resident live bait dealer and no nonresident dealer shall distribute live bait in the State without having it inspected and approved for desirability of species by the Pennsylvania Fish Commission.

AN ACT

Amending the act of December 15, 1959 (P. L. 1779), entitled "An act relating to fish; and amending, revising, consolidating and changing the law relating to fish in the inland waters and the boundary lakes and boundary rivers of the Commonwealth," regulating the sale of bait fish and changing the period for which purchased fish, bait fish or fish bait may be sold or held in possession.

The Fish Law of 1959.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 175, act of December 15, 1959, P. L. 1779 amended.

Section 1. Section 175, act of December 15, 1959 (P. L. 1779), known as "The Fish Law of 1959," is amended to read:

Section 175. Sales of Fish, *Bait Fish* and Fish Bait Regulated.—A person selling fish, *bait fish* or fish bait under the license provided by this article shall furnish the purchaser with a certificate or invoice of the sale, bearing the date of sale, the number of the license under which sold, the number of fish, *bait fish* and fish bait, and number of pounds sold. The certificate or invoice must be shown by the holder on demand of any fish warden, clerk of the market, constable or any person authorized to make arrests for violation of the laws of this Commonwealth relating to fish. The certificate or invoice shall authorize the sale, or holding in possession, of the fish, *bait fish* or fish bait so purchased for a period of [six] *fifteen* days after its date of issue, except in the case of bait fish or fish bait, which may be held in possession by dealers [and purchasers] until disposed of.

Act effective immediately.

Section 2. This act shall take effect immediately.
