AN ACT

To provide for the ordinary expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, interest on the public debt, and for public schools for the fiscal year July 1, 1964, to June 30, 1965, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1964.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. This act shall be known and may be cited as "The General Appropriation Act of 1964."

Section 2. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the General Fund to the several hereinafter named agencies of the Executive, Legislative and Judicial Departments of the Commonwealth for the payment of the salaries, wages or other compensation and travel expense of the duly elected or appointed officers and employees of the Commonwealth, for payment of fees for contractual services rendered, for the purchase or rental of goods, services, printing, equipment, land and buildings, and for payment of any other expenses as provided by law or by this act necessary for the proper conduct of the duties, functions and activities and for the purposes hereinafter set forth for the fiscal year beginning July 1, 1964, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1964:

I. EXECUTIVE DEPARTMENT

To the Governor

For the salaries, wages and all necessary expenses for the following purposes and activities, including the maintenance of the executive mansion, the expenses of entertainment of official guests, participation in the Governor's Conference, the expenses of the Executive Board and for the payment of traveling expenses of persons other than employees of the Commonwealth appointed by the Governor to represent the Commonwealth.

For the payment of the expenses of the Committee on Appropriations of the Senate in investigating schools, colleges, universities, penal institutions, mental hospitals, medical and surgical hospitals, homes and other institutions and agencies supported, in whole or in part, by appropriations from the State Treasury, in analyzing requests of the same, and of the various departments, boards and commissions of the Commonwealth for appropriations, and for the necessary clerical assistance and other necessary expenses in connection with the work of said committee in compiling data and information for the use of said committee and the Senate during Legislative Sessions and during the interim between Legislative Sessions to the discharge of such duties. The committee shall have the authority to examine and inspect all properties, equipment, facilities, files, records and accounts of any State office, department, institution, board, committee, commission or agency or any institu-

tion or agency supported, in whole or in part, by appropriation from the State Treasury and to administer oaths. The committee may issue subpoenas under the hand and seal of the chairman to compel the attendance of witnesses and the production of any papers, books, accounts, documents and testimony touching matters properly being inquired into by the committee and to cause the deposition of witnesses, either residing within or without the State, to be taken in the manner prescribed by laws for taking depositions in civil actions. The sum appropriated shall be paid on warrant of the Auditor General in favor of the chairman of said committee on the presentation of his requisition for the same. The Chairman of the Committee on Appropriations shall not later than thirty days after the termination of his term of office or until his successor is elected and also within thirty days after the adjournment of any regular or special session file an account with the Auditor General of the committee's expenses since the filing of the prior account \$35,000

Section 3. This act in not intended to be inconsistent with or to repeal any provision of any act enacted at this or any prior session of the General Assembly regulating the purchase of supplies, the ordering of printing and binding, the purchase, maintenance and use of automobiles, the method of making payments from the State Treasury for any purpose or the functioning of any administrative department, board or commission.

Section 4. No appropriation made by this act to any department, board, commission or agency of the Executive Department shall be available unless and until such department, board, commission or agency shall have complied with sections 604, 605 and 606 of The Administrative Code of 1929.

Section 5. The term "employees," as used in this act, shall include all directors, superintendents, bureau or division chiefs, assistant directors, assistant superintendents, assistant chiefs, experts, scientists, engineers, surveyors, draftsmen, accountants, secretaries, auditors, inspectors, examiners, statisticians, marshals, clerks, stenographers, bookkeepers, messengers and other assistants in any department, board or commission.

Section 6. The term "expenses" and "maintenance" shall include all printing, binding and stationery, food and forage materials and supplies, traveling expenses, training, motor vehicle supplies and repairs, freight, express and cartage, postage, telephone and telegraph rentals and toll charges, newspaper advertising and notices, fuel, light, heat, power and water, repairs or reconstruction of equipment, build-

ings and facilities, rent of real estate and equipment, premiums on workmen's compensation insurance, premiums on policies of liability insurance covering the operation of permanently assigned automobiles, premiums on surety bonds and medical payment insurance for volunteer workers in State institutions, the purchase of replacement or additional equipment and machinery other than passenger motor vehicles, and all other incidental costs and expenses including payment to the Department of Property and Supplies of mileage charges for the use of automobiles and of expenses or costs of services incurred through the Purchasing Fund.

Section 7. Purchase of supplies, materials and equipment shall not be deemed to be committed or encumbered until contracts covering said purchases have been entered into with the vendors.

Section 8. In addition to the amounts appropriated by this act, moneys received in payment for food and household supplies furnished to employes and other persons, except inmates by an institution, shall be paid into the General Fund and are hereby appropriated out of the General Fund to the several respective institutions for the operation and maintenance of said institutions.

Further, in addition to the amounts appropriated by this act, all moneys received from the Federal government, or from any other source as contributions for the programs provided herein, shall be paid into the General Fund and are hereby appropriated out of the General Fund for the purposes of the respective appropriations.

Section 9. That part of all appropriations in this act unexpended, uncommitted and unencumbered as of June 30, 1965, shall automatically lapse as of that date.

Section 10. The provisions of this act shall be severable. If any provision of this act is found by a court of record to be unconstitutional and void, the remaining provisions of the act shall, nevertheless, remain valid unless the court finds the valid provisions of the law are so essentially *and inseparably connected with and depend upon the void provision that it cannot be presumed the General Assembly would have enacted the remaining valid provisions without the void one, or unless the court finds the remaining valid provisions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.
