SB 1377

Amending the act of June 22, 1931 (P.L.594, No.203), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," amending a route in Crawford County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following route in Crawford County, act of June 22, 1931 (P.L.594, No.203), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," is amended to read:

Route 20011. Beginning at a point on the east line of Jamestown Borough; thence northeasterly and easterly in South Shenango Township to Snodgrass Corners; thence northeasterly in South Shenango Township to the west line of West Fallowfield Township at Campbell's Corners; thence northeasterly in West Fallowfield Township across Route 82 at Adamsville; thence continuing northeasterly in West Fallowfield Township, via Station Corners, to a point on the west line of East Fallowfield Township at the bridge over Crooked Creek; thence northeasterly in East Fallowfield Township to Kellogg's Corners; thence easterly through McAdoo's Corners to the west line of Greenwood Township; thence easterly in Greenwood Township, through Page Corners and Kazbee's Corners, to a point on Route 213 [at Campbell's Corners] approximately 1.5 miles south of Route 20018; thence from another point on Route 213 approximately 1.4 miles south of Route 20018 easterly in Greenwood Township through Campbell's Corners to the west line of Fairfield Township near Randell Corners; thence easterly in Fairfield Township through Randell Corners, Nelson's Corners, Calvin's Corners, and Calvin School Corners, to a point on the west bank of French Creek; thence southeasterly approximately parallel with French Creek, via Bonanza

School, to a point on Route 294 at Braymer Corners, in Crawford County, a distance of about 21.6 miles.
