AN ACT

SB 458

Amending the act of June 22, 1931 (P.L.594, No.203), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," amending and deleting routes in Lancaster County and York County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. As much of section 37 as relates to Routes 36013, 36082, 36115, 36164 and 36167, act of June 22, 1931 (P.L.594, No.203), referred to as the Township State Highway Law, Route 36115 added July 12, 1935 (P.L.806, No.301) and Routes 36164 and 36167 added June 25, 1937 (P.L.2143, No.437), are amended or deleted as follows:

Section 37. The township roads to be taken over, under the provisions of this act, in the COUNTY OF LANCASTER, are those situate and described as follows:

* * *

Route 36013. Beginning at a point in Salisbury Township intersecting Route 36012 at Springville; thence northwesterly through Salisbury Township to a point intersecting the Salisbury, Leacock, Earl Township line; thence following the dividing line between Upper Leacock, Leacock, and Earl Townships, by way of Ellsworth, to a point intersecting Route 244 about one and one-half miles west of New Holland; thence from a point in West Earl Township, again intersecting Route 244 about two miles west of New Holland, **[northeasterly through West Earl, Earl, and East Earl Townships, by way of Vogansville, Weavertown, and Martindale, intersecting Route 137] northeasterly through West Earl and Earl Townships to a point intersecting Route 36166 Vogansville; thence from a point intersecting Route 36052 at Martindale through Earl and East Earl Townships**, to a point on the western boundary line of Terre Hill Borough; thence from a point on the northern boundary line of Terre Hill Borough, northwesterly through East Earl, East Cocalico, and West Cocalico Townships, by way of Reamstown, Stevens and Schoeneck, intersecting Route 148, to a point in West Cocalico Township intersecting Route 607 at Cocalico, in Lancaster County, a distance of about **[29.63 miles] 26.15 miles. Also that a portion of Grist Mill Road in Earl Township that constitutes a bridge over the Conestoga Creek located about 0.3 mile west of Martindale.**

[Route 36082. Beginning at a point in Earl Township intersecting State-aid Application 353 about one mile north of New Holland Borough; thence northerly to a point intersecting Route 137 about one-half mile northwest of the Earl-East Earl Township line, in Lancaster County, a distance of about 1.00 mile.]

[Route 36115. Beginning at an intersection with Route 244 immediately west of the borough of New Holland, and extending in a northerly direction through Earl Township to an intersection with Route 36030, about 0.7 of a mile east of the Earl-West Earl Township line, in Lancaster County, a distance of about 3.3 miles.]

[Route 36164. Beginning at a point on Route 36013 about 0.7 of a mile southwest of its intersection with Route 36115; thence in a northerly direction through Earl Township to a point on Route 36030 about 0.2 of a mile northeast of the West Earl-East Earl Township line; in Lancaster County, a distance of about 0.8 of a mile.]

[Route 36167. Beginning at a point on Route 36013 at its intersection with Route 36029; thence in a northeasterly and northerly direction through Earl Township to a point on Route 244 about 0.3 of a mile west of New Holland, in Lancaster County, a distance of about 1.0 mile.]

Section 2. As much of section 67 as relates to Route 66041 of the act is amended to read:

Section 67. The township roads to be taken over, under the provisions of this act, in the COUNTY OF YORK, are those situate and described as follows:

Route 66041. Beginning at a point in [West Manchester Township, intersecting Route 124, about one mile northwest of the York City line;] *the City of York, intersecting Route 1070*; thence easterly through *the City of York*, West Manchester and Manchester Townships to a point intersecting Route 333 about .25 of a mile north of North York Borough; thence from a point on Route 250 at the northern boundary line of North York Borough, easterly through Manchester and Springetsbury Townships, to a point intersecting Route 66021 about .25 of a mile north of the Spring Garden Township line, in York County, a distance of about [4.08] 2.82 miles.

Section 3. This act shall take effect in 60 days.
