CHAPTER CXCVIII.

*A SUPPLEMENT to an Act, entitled, "An
Act for raising by way of Lottery, the Sum of
Twenty Thousand Dollars, for removing the Ob-
structions and improving the Navigation of the
River Susquehanna, and certain Branches there-
of."*

WHEREAS it has been represented to the
Legislature by Thomas Boude, Samuel
Bethel, Jacob Strickler, William P. Beatty, John
Evans and Christian Brenneman, six of the
managers named in an act of the Legislature of
this state, bearing date the eighteenth day of
February, one thousand eight hundred and five,
for the purpose of raising by way of lottery,
twenty thousand dollars, that Adam Reigart, jun-
Philip

Philip Diffenderfer, and Michael Gundacker, three of the managers named in said act, have declined the duty enjoined on them: And whereas it has also been requested by the said Thomas Boude, Samuel Bethel, Jacob Strickler, William P. Beatty, John Evans, and Christian Brenneman, that the places of the said Adam Reigart, jun. Philip Diffenderfer and Michael Gundacker, may be supplied with other persons and that an additional number of managers may be appointed, and also that the place of drawing said lottery may be changed from the borough of Lancaster to the town of Columbia, in the county of Lancaster: Therefore,

Section 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met and it is hereby enacted by the authority of the same,* That Emanuel Reigart, Hugh Wilson, and Michael Rine, be, and they are hereby appointed managers in the room of the said Adam Reigart, jun. Philip Diffenderfer, and Michael Gundacker, and that Abraham Witmer, Christian Stoner, Andrew Kauffman, George Pretzler, Nathaniel Barber, Philip Gosler, and George Snyder, of the county of Lancaster, Thomas Grant, of the town of Northumberland, in the county of Northumberland, James Duncan, of Aaronsburg, in the county of Centre, John Blair, and Robert Allison, of the town of Huntingdon, in the county of Huntingdon, and George M'Clelland, of Lewistown, in the county of Mifflin, be, and they are hereby appointed additional managers, and that the said managers, in conjunction with Thomas Boude Samuel Bethel, Jacob Strickler, William P. Beatty, John Evans, Christian Brenneman, Joseph
