An ACT abolishing the offices of receiver-general and master of the rolls, and transferring the duties therein performed to other offices, and for other purposes.

Section I. B^E it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is bereby enacted by the authority of the same, That from and after the tenth day of May next, the offices of receiver-general and master of the the receiver rolls shall cease, determine, and be abolished, and the books, records, and papers belonging thereto, shall immediately after that period, be deposited in other offices, as is hereinafter mentioned.

SECT. II. And be it further enacted by the authority aforesaid, That all the books, papers, and other documents in the receiver-general's office, and all the patent books, records, and documents relating to the titles of lands which are in the roll's office, shall be delivered to the secretary of the land-office, and be by him deposited in his office; and all the books, papers, and other documents which are in the office of master of the rolls, containing the records of, or relative to the enrolment of laws or other acts of the legislature, shall be delivered to the secretary of the commonwealth, and be by him deposited in his office.

WHEREAS it appears to the Legislature by the petition and certificate attached thereto, of John Huton, of Juniata township, in Cumberland county, that he was wounded in the leg in the service of his country, at a place called the Round-abouts, on Raritan river, in the year one thousand seven hundred and seventy-seven, that he is now old and rendered unable to follow any employment on account of said wound not being healed: Therefore:
