arbitrators, provided, &c.

Allowanceto That the arbitrators respectively shall receive the sum of one dollar, for each and every day necessarily spent by them in the investigation of any cause to them submitted under the provisions of this act, but they shall receive no daily pay or other compensation, unless they make their report, and transmit the same to the prothonotary within fourteen days, excepting in the city and county of Philadelphia, which shall not exceed seven days after they shall have agreed upon the same.

arbitrators refusing to attend, and how recoverable.

SECT. XVIII. And be it further enacted by the authority aforesaid, Penalty upon That in case any one or more arbitrator or arbitrators chosen and notified as aforesaid, shall neglect or refuse to attend and take upon him or themselves, the duties of their appointment, each of them so offending shall, for every such offence, forfeit and pay the sum of two dollars, to be recovered by either party before a justice of the peace, in the same manner as debts of equal amount are by law recoverable, unless he or they can satisfy such justice, that his or their absence was occasioned by sickness or some other unavoidable cause.

> SECT. XIX. And be it further enacted by the authority aforesaid, That the act to which this is a supplement, and an act supplementary thereto, passed on the twenty-eighth day of March, one thousand eight hundred and eight, be, and they hereby are rendered perpetual, any thing contained in the said acts to the contrary notwithstanding.

Repeal of parts of former laws.

SECT. XX. And be it further enacted by the authority aforesaid, That after this act shall come into operation, so much of any law or laws as is or are hereby altered or supplied, be, and the same is hereby repealed.
