And be it further enacted by the authority aforesaid, That the sum of one thousand dollars be, and the same is hereby granted to the trustees of the Harrisburgh Academy. to enable them to purchase a lot of ground, whereon to erect a suitable building for the said academy or public school, and to procure a pair of globes and such other astronomical and mathematical apparatus as may be necessary for the said academy, and that the same be paid by a warrant to be drawn by the governor on the state-treasurer, out of any unappropriated money in the treasury.

An ACT for the further establishment and regulation of Election districts.

Section I. B^E it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That all that part of Straban township, in the county of Regulation Adams, east of the road leading from Shriver's mill to George of election Adams, east of the road leading from our ver's min to George districts in Lashell's and Hunterstown, and down the Beaver dam run to Adams Conewago, which is now annexed to the third election district, county. be and is hereby re-annexed to the remaining part of said township which is included in the first election district, and the whole of said township of Straban shall hereafter be included in the first election district, and hold their elections at the court-house in the borough of Gettysburg.

SECT II. And be it further enacted by the authority aforesaid, That the following shall be and the same is hereby declared an election In Beaver district in Beaver county: that is, Beginning on the western boun-county. dary line of this State, where the Tuskaraway road crosses the same, thence a direct line by John Kelso's mill to Big Beaver creek, thence up said creek to the plantation of Alexander Wright, thence a due west course to the western boundary line of the State aforesaid, thence south on said line to the place of beginning; and the electors therein shall hold their general elections in the academy in the town of Griersburg; and that the township of Hanover in the said county, be and the same is hereby erected into a separate election district, and the electors thereof shall hold their general elections at the house now occupied by David Patton, in said township.

SECT. III. And be it further enacted by the authority aforesaid, In Bedford That the electors of Hopewell township, in the county of Bedcounty. Lane, on the south side of Juniata, near the mouth of Yellow creek.
