An act making appropriations for the improvement of certain roads in the western counties, and authorizing the courts of the respective counties to appoint fit persons to view and lay out the same," passed the tenth day of April one thousand eight hundred and seven, shall have full power and authority in all cases in which any person or persons who shall allege that he, she or they shall sustain damage in pursuance of any road laid out under the authority of the said act as respects its width or oblique direction through or over any in or out-lot in the vicinage of any towns mentioned in the said act, or any other improvement; that on any such person or persons petitioning any of the respective courts stating in a plain intelligible manner in which any such petitioner may be affected in his or their buildings or other improvements, the courts of quarter sessions of the respective counties named in the aforesaid act shall have authority to exercise such powers in giving relief to any person or persons who has or may suffer unreasonable damage by any road laid out by virtue of the said act, as they have or may lawfully exercise under the authority of an act, entitled "An act for laying out and keeping in repair the public roads and highways within this Commonwealth, and for laying out private roads," passed the sixth day of April, one thousand eight hundred and two.
