And be it further enacted by the authority aforesaid, Limitation of That this act shall be and continue in force until the first day of January, which will be in the year of our Lord, one thousand eight hundred and twenty-seven: Provided, That for the litransactions. quidation and settlement of all the past transactions and accounts of the said company, the corporate powers thereof shall be and continue effectual to all intents and purposes: And provided further, That if at any time hereafter it shall appear to the legislature, that the operation of the privileges hereby granted to the said company, are injurious to the interest of the citizens of this commonwealth, or to the trade of the United States, the power of the legislature to repeal or annul this act, shall in no wise be denied, but such repeal shall not affect any engagement made previously thereto by said company.

An ACT authorizing the loan of money from the state to the commissioners of Mercer county.

Loan to be granted to the commissioners of Mercer county, Commissioners to give bond åс. Times of payment.

Previded, That the said commissioners shall first give bond, with warrant of attorney, to confess judgment to the commonwealth,

with sufficient security to the satisfaction of the governor, for the payment of the said loan, in three equal annual instalments, to commence three years from and after the passing of this act, with interest from the reception of said loan.
