conditioned for the faithful performance of the several trusts confided to him by this act, which bond may be sued for the use of any person having an interest in the estate of the said Philip Bottenfeld.

## CHAPTER XXXIII.

An ACT to enable the commissioners of Huntingdon county to collect certain taxes in the counties of Clearfield and Cambria.

WHEREAS the law passed the twenty-sixth day of March, one thousand eight hundred and four, entitled "An act to erect part of Lycoming, Huntingdon and Somerset counties into separate county districts," made no provision to enable the commissioners of the county of Huntingdon to collect the arrears of taxes due on unseated lands, or the taxes levied and assessed the same year in those parts of Huntingdon county that were included in the counties of Clearfield and Cambria by the said act; Therefore,

Commissioners of Huntingdon county authorized to collect certain taxes, ky.

SECT. 1. Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same. That the commissioners of Huntingdon county be, and they are hereby authorized and directed to collect and enforce the payment of all taxes on unseated lands that were assessed on or before the year one thousand eight hundred and four, in those parts of Allegheny township, Huntingdon county, which were included in the counties of Clearfield and Cambria, and all sales of unseated lands for taxes assessed as aforesaid within the said parts of the counties of Clearfield and Cambria, agreeably to the directions of the act, entitled " An act directing the mode of selling unseated lands for taxes," shall be in law and equity valid and effectual, and shall vest in the purchaser or purchasers of any lands sold as aforesaid all the estate, right and title to the said lands as if the said lands were now in the county of Huntingdon.

Directed to issue warrants to collectors, &c.

SECT. II. And be it further enacted by the authority afor esaid, That the present commissioners of Huntingdon county shall issue their warrants with a duplicate of the taxes assessed in the year one thousand eight hundred and four, by the assessors of Allegheny township, Huntingdon county, in that part of Cam-

bria county that formerly belonged to Allegheny township, Huntingdon county, to the collector in said township, authorizing and requiring him to demand, receive and recover, of and from every person named in such duplicate, the sum wherewith such person stands charged, and pay the amount of said taxes to the treasurer of Huntingdon county.

## CHAPTER XXXIV.

An ACT for the relief of the Trustees of Youghiogeny Bridge in Somerset county.

WHEREAS it appears that by an act of the legislature of the fourth of April, one thousand eight hundred and five, a sum of four hundred dollars was appropriated to aid the building of a bridge over the Youghiogeny river in Somerset county, which sum was to be drawn out of the treasury of Bedford county, out of arrearages of state taxes conceived to be due from said county; And whereas the trustees appointed to superintend the building of the bridge aforesaid proceeded to contract for the erection of said bridge, which bridge was completed, but it has since been ascertained that no taxes of the above description could be ever recovered from said county; And whereas, the aforesaid trustees were compelled to pay the full sum of four hundred dollars out of their own money in consequence of not receiving the sum above alluded to, for the relief of whom; Therefore,

SECT. 1. Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the state treasurer state treasurer is hereby authorized and required to pay to Jacob Harlzell and Harlzell, esquire, John Malach, James Tannihill and Richard others 400 dok-lars. Green, or to their order, the sum of four hundred dollars out of any unappropriated money in the treasury.
