Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Robert Hays and John McConaughy, administrators of the estate of James Scott, deceased, be and they are hereby authorized and empowered by a sufficient deed or deeds in law, to convey, release and assure to George Lashells, his heirs and assigns, a lot of ground in the borough of Gettysburg, in the county of Adams, situate on the north side of Middle-street, numbered one hundred and forty-four, with all the right, title, interest, property and estate whatsoever, which the said James Scott had in his life time to the said lot of ground, with the appurtenances, which deed or deeds when executed by the said administrators, shall be as good and effectual in law, to all intents and purposes,. as if the said James Scott had fully executed his contract aforesaid, and conveyed said lot of ground to the purchaser in his lifetime.

## CHAPTER XLIII.

An ACT supplementary to an act entitled "An act to enable the governor to incorporate a company to make an artificial road from the east end of Perkiomen bridge, in the county of Montgomery, passing through Pottsgrove and by the White Horse tavern, in Amity township, to the borough of Reading in Berks county.

Sect. 1. BE it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That John Clement Stocker, William Allibone, Joseph E. Howel, Mark Richards, John Vaughan, Jeremiah Piersol and George W. Morgan, of the city of Philadelphia; Thomas Norton James Hart, William West and John Barclay, of the Northern Liberties; John M. Price, Samuel Mechlin, junior, and Jacob Rex of Germantown; Samuel Maulsby, Daniel Hitner and Matthias Shively, of Montgomery county; George Douglass, Matthew Brooke, John Brower, Conrad Fegar and Lewis Reese, of Berks county, be and they are hereby appointed commissioners who shall have like powers, and be subject to like duty as those already appointed by the act to which this is a supplement.

And be it further enacted by the authority aforesaid, when gates may That when the said company shall have completed the distance be excepted. of five miles of said road from Perkiomen bridge, and shall have caused the same to be inspected and approved of agreeably to the act to which this is a supplement, then the governor shall grant licences to the said company to erect a gate or gates for the purpose of demanding and receiving toll, agreeable to the rates and conditions prescribed by the act aforesaid, and so from time to time as the said road progresses to any distance not less than five miles.

SECT. IV. And be it further enacted by the authority aforesaid, Governor to That the governor is hereby authorized and required to sub-shares. scribe on behalf of this commonwealth, for one hundred and fifty shares of stock in the said company, and he is also required as soon as any distance not less than five miles of the said road is completed and approved of, to draw his warrant on the treasury in favour of the said company, for a proportional part of said subscription, and so from to time as the road progresseth.

SECT. V. And be it further enacted by the authority aforesaid, That the said company are hereby authorized to lay out and construct the said turnpike road from the white horse tavern in Amity township, in Berks county, so as to meet the Centre turnpike road at any point they may conceive will embrace the shortest distance with the best ground.

SECT. VI. And be it further enacted by the authority aforesaid, Part of the original and the contribution of the contribution That so much of the act to which this is a supplement, as is hereby altered and supplied, be and the same is hereby repealed.
