CHAPTER CII.

An ACT to enable the governor to incorporate a company to make an artificial road from the Philadelphia and Wilmington post road, near John M'Ilvain's to intersect the Philadelphia, Brandywine and New London turnpike road, on the land of George Davis, in Delaware county.

Sect. 1. BE it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That William commissioners Graham, William Anderson, Thomas B. Dick, Joseph Engle, appointed. Samuel Anderson, Jonas Eyre, John Crosby, John Newbold, John MIlvain, Abraham Trimble and George G. That when twenty persons or more shall have subscribed seventyfive shares of the said stock, the commissioners shall certify under their hands and seals the names of the subscribers, and the number of shares subscribed by each, to the governor, and thereupon it shall and may be lawful for the governor by letters patent, under his hand and the seal of the state, to create and crect the subscribers, and if the said subscriptions be not full at the time, then also those who shall afterwards subscribe to the number aforesaid, into one body politic and corporate, in deed and in law, by the name, style and title of, "The president, managers and company of the Ridley turnpike road;" and by the said name the subscribers shall have perpetual succession and and privileges, all the privileges and franchises incident to a corporation, and shall be capable of taking and holding their said capital stock, and the increase and profits thereof, and of enlarging the same from time to time by new subscriptions, in such manner and form as they shall think proper, if such enlargement shall be found necessary to fulfil the intent of this act, and of purchasing, taking and holding to them and their successors and assigns, and of selling, transfering and conveying in fee simple, or for any lesser estate, all such lands, tenements, hereditaments and estate, real and personal, as shall be necessary to them in the prosecution of their works, and of suing and being sued, and of doing all and every other matter and thing which a corporation or body politic may lawfully do.

Sect. III. And be it further enacted by the authority aforesaid, That the commissioners aforesaid as soon as conveniently may be, after the said letters patent shall be obtained, shall give notice in two of the public newspapers printed in Philadelphia, of a time and place by them to be appointed, not less than ten days from the publication of the first notice, at which time and place the said subscribers shall proceed to organize the said corporation. and shall choose by a majority of votes, of the said subscribers by ballot to be delivered in person or by proxy, duly authorized, one president and six managers, one treasurer, and such other officers as they shall think necessary to conduct the business of the said company for one year, and until such other officers shall be chosen; and shall and may make such by-laws, rules, orders Turdier privi-irger and restrict and regulations, not inconsistent with the constitution and laws

An ACT to authorize Rebecca Miles of the city of Philadelphia, widow, to sell and convey certain lots and lands therein mentioned.

SECT. 1. Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly

becca Miles of the city of Philadelphia, widow of James Miles, sell certain real deceased, and guardian of his minor children, Catharine Miles, Samuel Miles, William Miles and James Miles, be, and she is hereby authorized to sell and convey in such manner as she shall judge most for the benefit of the said minors, and for the best price that can be got for the same, all the undivided shares, interest, right and estate of the said Catharine Miles, Samuel Miles, William Miles and James Miles, of all and every the lots, lands and real estate, in and adjoining the town of Milton, in Turbut township, in the county of Northumberland, which they are in anywise entitled to or interested in, which descended to, and vested in them by operation of law, or in any manner, by, from, or under William Wister, of the city of Philadelphia, or by, from, or under their uncle Samuel Miles, who respectively died intestate and without issue, so far as respects the said real Andro execute estate, and to execute a deed or deeds of the same to the pur-conveyance.
