SECT. XI. *And be it further enacted by the authority aforesaid,* That it shall be the duty of the high constable to give notice of the elections, by setting up advertisements in the market, and three other public places in the said borough, ten days previously thereto, he shall attend and see that the same is opened at the time and in the manner directed by this act; *Provided,* that David Cooke, and James Anderson, of the said towns, or either of them, shall publish and superintend the election to be held on the second Tuesday of April next, as herein before directed.

How notice of elections to be given. Duties of the high constable. D. Cooke and J. Anderson to superintend the first election.

SECT. XII. *And be it further enacted by the authority aforesaid,* That if any person or persons shall think him, her or themselves aggrieved, by any thing done in pursuance of this act, he, she or they, may appeal to the next court of quarter sessions, to be held for the proper county, upon giving security according to law, to prosecute his, her or their appeal with effect; and the court having taken such order therein as shall seem to them just and reasonable, the same shall be conclusive against all parties.

Appeals may be had to the court of quarter sessions.

CHAPTER LX.

An ACT to exonerate from the effects of a judgment, the estate of the late Frederick Antes, deceased.

SECT. 1. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same,* That as soon as Frederick Evans, administrator of the late Frederick Antes, deceased, shall have received from the commissioners of taxes of Northumberland county, one hundred and twenty-nine pounds, eleven shillings, being the amount due the said decedent for his commission and mileage, on his whole receipts and payments, as county treasurer, and shall have paid the same to the state treasurer, he the said administrator, and the estate of the said Frederick Antes, shall be exonerated from the payment of six hundred and one pounds, thirteen shillings, and five pence; for which judgment was had in the court of common pleas of Northumberland county,

CHAPTER LXI.

An ACT for the relief of Jacob Rouse, a wounded soldier.

SECT. 1. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the state-treasurer be and he is hereby required to pay to Jacob Rouse, of Northampton county or his order, forty dollars, immediately after the passage of this act, and forty dollars annually, to be paid half yearly during life, to commence from the first day of January, one thousand eight hundred and twelve.*

CHAPTER LXII.

An ACT for the relief of John Wilson, and David Hess.

WHEREAS Margaret Wilson, widow, for herself and children, purchased of Andrew Allen, two hundred and eighteen acres of land in Allen township, Northampton county, in the year one thousand seven hundred and seventy-six, at the rate of twelve dollars per acre; and whereas, the said consideration money was confiscated for the use, and paid into the treasury of the commonwealth, agreeable to an act of assembly, passed the sixth day of March, one thousand seven hundred and seventy-eight; and whereas, by sundry legal conveyances, the estate has since been vested in John Wilson, and David Hess; and whereas, the said John Wilson was, in October, one thousand eight hundred and nine, by due course of law, evicted from fifty two acres and twenty perches of said premises, by a title paramount, in a certain Margaret Delaney, of the kingdom of Great Britain; and whereas, David Hess was on the same day, in like manner, by the title of the
