Sureties to be given for the faithful appro-priation of the chaser or purchasers, all the right, title and interest, which the said lunatic hath in such real estate; the money arising from the sales thereof, to be applied to the payment of the debts of said lunatic, and maintenance of himself and family: provided. that the said William Sharpless, shall, before he proceeds to sell and convey any part of the real estate of the said William Smith, enter into recognizance, with sufficient security, before the court of common pleas of Chester county, where the said estate lies, that all the monies arising from the sale of the real estate authorized by this act shall be faithfully applied to the purposes aforesaid.

CHAPTER XXIV.

A SUPPLEMENT to an act, entitled, " An act to authorize the governor to incorporate a company for erecting a permanent bridge over the river Schuylkill, at or near Pawling's ford, in the counties of Montgomery and Chester.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly
Races of tolls for met, and it is hereby enacted by the authority of the same, That passing the shall be lawful from and after the passing of this act, for the said company, and their successors, to demand and receive toll from travellers and others, crossing the said bridge, agreeably to the following rates, a list of which shall be placed in some conspicuous place near the said bridge for the information of passengers, to wit, for every score of sheep six cents; for every score of hogs, ten cents; for every score of cattle, twenty cents; and so for a greater or lesser number; for every horse or mule, three cents; for every horse and rider, four cents; for every foot passenger, one cent; for every sulkey, chair or chaise, with one horse and two wheels, ten cents; for every chariot, coach, phæton or chaise, with two horses and four wheels, twenty cents; for either of the aforesaid carriages with four horses, thirty cents; and for every other carriage of pleasure, under whatever name, the like sum according to the number of wheels and of the horses drawing the same; for every stage waggon with two horses, eighteen cents; for every such waggon drawn by four horses, twenty-eight cents; for every sleigh, six cents, for each horse drawing the same; for every sled, four cents for each horse drawing the same; for every wag-

gon or cart, five cents for each horse drawing the same; and two oxen shall be estimated as equal to one horse; nor shall any carriage or waggon drawn by more than six horses or oxen. be entitled to pass over said bridge; provided always, that no Persons attendtoll shall be taken from any person attending funerals, or walk- ing funerals and ing in military procession, or from persons belonging to the stone, exempted from toll, &c. military processions or from muster on days of training, nor from any person going to or returning from the general election, nor going to or returning from public worship, nor And children gord children going to or returning from school: and provided also, ing to and from school. that nothing in this act shall be so construed as to prevent the company may said company from contracting with any person or persons de-form annual contracts with indisirous of using said bridge for an annual sum in lieu of the toll viduals. herein before mentioned.

SECT. II. And be it further enacted by the authority aforesaid, That so much of an act to which this is a supplement, as far as Part of a formet respects the aforesaid bridge, as is altered or supplied, be, and the act repealed, same is hereby repealed.

CHAPTER XXV.

A SUPPLEMENT to the act, entitled, " An act to incorporate the subscribers to the Insurance Company of North America.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly tnet, and it is hereby enacted by the authority of the same, That The funds may from and after the passing of this act, the funds of the said be vested in evidence of debt of company may from time to time be vested in securities for, or bank stock, &c. evidence of debts due by the United States, or in the stock of any bank or other institution, which is or may be incorporated in the state of Pennsylvania, in their own stock or in bills of exchange, or may be loaned to the state of Pennsylvania, or on the security of real estate within the same.

SECT. 11. And be it further enacted by the authority aforesaid, rifteen directors That for the well ordering the affairs of the said corporation, to be chosen. there shall hereafter be fifteen directors, (stockholders in said company, chosen by ballot, on the second Tuesday of January, annually, by a plurality of votes of the stockholders present, or by proxy; and the directors so chosen, shall serve for one year next Term of service. ensuing the elections respectively, and until others shall be cho-
