CHAPTER CVII.

An ACT authorizing the governor to incorporate a company, to make an artificial road from the town of Munchester, in the county of York, to intersect the York, Conewago, and Canal turnpike road, between the fifth and seventh mile stones.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That commissioners named. George Small and Andrew Cramer, of the county of York, Frederick Nagle, James Mehaffey, Matthias Rank, Lewis Leader, Abraham Zublin and Henry Cassel, of the county of Lancaster, be and they are hereby appointed commissioners to do and perform the several duties herein after mentioned, viz.
