BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That Time of holding from and after the next April term, in the county of Adams, the within Adams county of common place, quarter sessions of the peace, and or county, altered. courts of common pleas, quarter sessions of the peace, and orphans' court, shall be holden in said county on the Mondays next succeeding the same courts in Cumberland county, and that the said courts continue one week; and the judges of the same are hereby authorized and empowered to adjourn said courts to such times and in such manner as is provided by the act to which this is supplementary.
