That the state treasurer be, and he is hereby directed to pay unto Daniel Welker, of Franklin county, or order, forty dollars immediately after the passing of this act, and an annuity of forty dollars, payable half yearly during his life, to commence from the first day of January last.

CHAPTER CXCIV.

An ACT to extend the fifth section of the act, entitled, "An act laying a tax on dogs in certain counties, and for other purposes."

Fifth section of the act passed 23d March, 1809 taxing dogs, made general.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That from and after the passing of this act the fifth section of the act, entitled, "An act laying a tax on dogs in certain counties, and for other purposes," passed the twenty-third day of March, one thousand eight hundred and nine, be and the same is hereby extended and declared to be a general law throughout this commonwealth.

CHAPTER CXCVI.

A further SUPPLEMENT to an act, entitled, "An act to raise by way of lottery, a sum not exceeding eight thousand dollars for the use of, and benefit of the minister, wardens and vestry, of the African episcopal church of Saint Thomas, in the city of Philadelphia.

Commissioners to carry the original act into effect.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That Joseph Worrell, George Bartram, Matthew Weaver, Isaac Herbert, and Thomas T. Stiles, be and they are hereby appointed commissioners, and the said commissioners be and they are here-

by authorized and empowered to carry the said act into execution, subject to the qualifications and restrictions contained in the original act, passed on the sixth day of February, one thousand eight hundred and four; and in case of death or resignation of any or either of the said commissioners, a majority are hereby authorized and empowered to raise the sum of five thousand five hundred dollars, being the sum deficient as contemplated by the original act. A majority may not.

CHAPTER CXC VII.

An ACT granting a tract of donation land to the legal heirs of John Knapsnyder, deceased, late a soldier in the Pennsylvania line.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the land officers be, and they are hereby directed to draw and patent a tract of donation land, containing two hundred acres, unto the legal heirs of John Knapsnyder, deceased, late a soldier in the Pennsylvania line, clear of patenting fees. A tract of donation land granted to the heirs of John Knapsnyder.
