CHAPTER CCV.

An ACT to extend the state road laid out from Somerset to the borough of Washington, to the western boundary of this state.

Sect. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the governor be and he hereby is authorized and required, on or before the first day of May next, to appoint three disinterested commissioners, one of whom shall be a practical surveyor, to lay out and distinctly mark a state road fifty feet wide, beginning at the town of Washington in the county of Washington, and running thence the best and nearest route to West Middleton in said county, and thence to intersect the
