SECT. 1. Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That all the right, title and interest of this commonwealth, by reason of the death of the said John Waltz, of and in a certain lot of twelve acres of land, be the same more or less, with the appurtenances, situate in Springfield* township, in the county of Bucks, and adjoining lands of Conrad Hess, Joseph Hess, Samuel Treigler, and others, be and the same is hereby released to John Theright of the Easterline and Magdalena Easterline, their heirs and assigns, as &c. released to tenants in common, and also all the right, title and interest of the &c. commonwealth of and in the personal estate of the said John Waltz, in the hands of George Rodrock and Valentine Opp, the administrators of the said John Waltz, or in the hands of any other person or persons, with the interest due and accrued thereon: provided, that nothing in this act contained shall in any wise Prov. prejudice the rights of individuals, or impair any other title to the said real or personal estate, than that which the commonwealth has or might have by reason of the said escheat.

CHAPTER XXIV.

A SUPPLEMENT to an act entitled, " An act to incorporate the Phoenix Insurance Company of Philadelphia."

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That from and after the passing of this act, the capital stock of the stock, &c. Phoenix Insurance Company of Philadelphia, shall be deemed atter to be 480,000 Bollars and taken to be the sum of four hundred and eighty thousand dollars, divided into six thousand shares of eighty dollars each, and no more: Any thing in the act to incorporate the said company, or the act to continue the same, to the contrary notwith-Provided, that nothing in this act contained shall be Proviso taken or construed to affect or lessen the security of any contract whatsoever, which may have been entered into with the said company before the passing of this act.

SECT. 11. And be it further enacted by the authority aforesaid, That the capital stock and funds of the company may from time to time be invested in their own stock, or may be loaned to the state of Pennsylvania, in such sums as may be deemed proper by the board of directors, or employed in such other manner as is authorised by the act to which this is a supplement.

CHAPTER XXVI.
