CHAPTER LVI.

An ACT to validate and confirm the proceedings of Joshua Davis, late justice of the peace in Northampton county.

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same,* That all acknowledgments of deeds and other official and judicial proceedings had and taken before Joshua Davis, a justice of the peace in East Penn township, Northampton county, prior to the first day of April, one thousand eight hundred and eleven, be and the same are hereby confirmed and made as valid as if he had resided within the district for which he had been appointed. CHAPTER LVII.

An ACT for the relief of Joseph Horner.

WHEREAS Joseph Horner purchased of Andrew Allen, one hundred and eighty-two acres and sixty-seven perches of land in Allen township, Northampton county, in the year one thousand seven hundred and seventy-six, at the rate of twelve dollars per acre, eight hundred and thirty-two pounds nineteen shillings of said consideration money was confiscated for the use of the commonwealth, and paid into the treasu-

ny thereof, in pursuance of an act of the general assembly, passed the sixth day of March, one thousand seven hundred and seventy-eight; and the said Joseph Horner was in October, one thousand eight hundred and nine, by due course of law evicted from the premises by a title paramount in a certain Margaret de Lancy, of the kingdom of Great Britain therefore,

SECT. I. *Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same,* That the state treasurer is hereby authorized and required to pay to Joseph Horner, the sum of three hundred and fifty-four dollars and eighty-eight cents, as full compensation for all damages he has sustained, by being evicted by due course of law from one hundred and eighty-two acres and sixty-seven perches of land, in Allen township, Northampton county, held by him under a title derived from this commonwealth.

CHAPTER LVIII.

An ACT for the relief of John Stengor.

WHEREAS John Latimore on the first day of May, one thousand seven hundred and seventy-six, purchased of Andrew Allen, one hundred and fifty-nine acres and sixty perches of land in Allen township Northampton county, at the rate of twelve dollars per acre, six hundred and fifty-seven pounds three shillings of which said consideration money was confiscated for the use of the commonwealth and paid into the treasury thereof, in pursuance of an act of the general assembly, passed the sixth day of March, one thousand seven hundred and seventy-eight: *and whereas,* by sundry legal conveyances, ninety-six acres and three quarters of the aforesaid estate, has since been vested in John Stengor, from which he was by due course of law, in October, one thousand eight hundred and nine, evicted by title paramount in a certain Margaret de Lancy, of the kingdom of Great Britain: therefore,

SECT. I. *Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same,* That the state treasurer is hereby authorized and required to pay to John Stengor, one hundred and fifty-one dollars and sixty
