Sect. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That Caleb Kirk, Isaac Kirk, Henry Irwin, Jacob Spangler, Cornelius Commissioners Garretson, John Myer, John Mosser, Benjamin Kurtz, Jacob named. SECT. II. And be it further enacted by the authority aforesaid,

That when fifty persons or more shall have subscribed two hundred shares of the said stock, the commissioners shall certify under their hands and seals, the names of the subscribers and the number of shares subscribed by each, to the governor of this commonwealth; and thereupon it shall and may be lawful for the governor by letters patent under his hand and the seal of the state, to create and erect the subscribers, and if the said subscriptions be not full at the time, then also those who shall afterwards subscribe to the number aforesaid, into one body politic and corporate, in deed and in law, by the name, style and title of Style of corpora "The President, Managers and Company of the Yellow-Breeches turnpike road;" and by the said name, the subscribers shall have perpetual succession, and all the privileges and franchises incident to a corporation, and shall be capable of taking and holding their said capital stock and the increase and profits thereof, and of enlarging the same from time to time by new subscriptions, in such manner and form as they shall think proper, if such enlargement shall be found necessary to fulfil the intent of this act, and of purchasing, taking and holding to them and their successors, and of selling, transferring and conveying in fee simple, or tor any less estate, all such lands, tenements, hereditaments and estates real and personal as shall be necessary to them in the prosecution of their works, and of suing and being sued, and of doing all and every other matter and thing which a corporation or body politic may lawfully do.

SECT. 111. And be it further enacted by the authority aforesaid. That the commissioners aforesaid, as soon as conveniently may be after the said letters patent shall be sealed and obtained, shall

give notice in two of the public newspapers in the borough of Notice of the York, and elsewhere, if occasion may require, of a time and be given of or place by them to be appointed, not less than twenty days from gamizing the corporation. the publication of the first notice, at which time and place the said subscribers shall proceed to organize the said corporation, and shall choose by a majority of votes of the said subscribers, by ballot, to be delivered in person or by proxy duly authorized, one president, and twelve managers, one treasurer, and such what officers t other officers as they shall think necessary to conduct the busi-be chosen. ness of the said company for one year, and until such other officers shall be chosen; and the said managers so chosen and their successors are hereby authorized to make a turnpike road by the nearest and best route, from the western end of the Harrisburg bridge now building, to the bridge to be built over the Yellow-Breeches creek, near its confluence with the Susquehanna, and thence to the head of the York and Conewago canal turnpike road; and shall and may make such by-laws, rules, orders and Authorized to regulations not inconsistent with the constitution and laws of make by-laws this commonwealth, as shall be necessary for the well ordering the affairs of the said company, and generally have like powers, authorities and privileges necessary for carrying on and complet-powers and privileges necessary for carrying on and complet-vileges and privileges and be subject to all the duties, qualisticities and profits in proportion to the distance as are granted to tike tolls and profits in proportion to the distance as are the Susquehanna and York tumpier or and granted to the president, managers and company, of pike road company, the Susquehanna and York borough turnpike road: provided, Proviso, as to that if the company shall not proceed to carry on the said work mencing and completing the work. seven years afterwards complete the said road according to the true intent and meaning of this act, then in either of these cases all and singular the rights, liberties and franchises hereby granted to the said company shall revert to this commonwealth.

SECT. IV. And be it further enacted by the authority aforesaid, Repeal of a cor-That the act entitled "An act to enable the governor to incor- tain act. porate a company to make an artificial road by the best and nearest route from the confluence of the Yellow-Breeches creek with the river Susquehanna to intersect the York and Conewago canal turnpike road, at any point the board of managers shall think most eligible," be and the same is hereby repealed.
