## CHAPTER LXXXVIII.

A further SUPPLEMENT to an act for acknowledging and recording of deeds.

SECT. 1. Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That each alderman of the city of Philadelphia and justice of the peace of this commonwealth shall have power to take and receive the acknowledgment or proof of all deeds, conveyances, mortgages or other instruments of writing, touching or concerning any lands, tenements or hereditaments situate, lying and being in any part of this state, and also power to take and receive the separate Further powers, examination of any feme covert touching or concerning her right of dower, or the conveyance of her estate, or right in or to any such lands tenements or hereditaments, as fully to all intents and purposes whatsoever, as any judge of the supreme court or president or associate judge of any of the courts of common pleas within this commonwealth.

## CHAPTER LXXXIX.

An ACT to enable the governor to incorporate a company, for making a turnpike road from the Harrisburg bridge to Berlin in Adams county.

SECT. 1. Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That John Shoch of Harrisburg, David Brenizer, Jacob Merkle, Christian Mohler, William Harkness, junior, John Beelman, John Musselman and William Bryson, of Cumberland county; Frederick Eichelberger, John Hurst, Abraham Kinsley, Thomas Wilson, Thomas Black, and Emanuel Smith, of York county; and Jacob Harbaugh and Valentine Hollingar, of Adams county, be and they are hereby appointed commissioners to do and perform the several duties hereinafter mentioned: that is to say, they shall on or before the first day of June next, procure one or more\* books and enter therein as follows:

"We, whose names are hereunto subscribed, do promise to pay to the President, Managers and Company of the Harrisburg and Berlin turnpike road company the sum of one hundred dollars for each and every share of stock in the said company, set oppo-

And be it further enacted by the authority aforesaid, That when forty persons or more shall have subscribed two 200 shares being hundred shares of the said stock, the commissioners shall certify may issue. under their hands and seals the names of the subscribers and the number of shares subscribed by each to the governor, and thereupon it shall and may be lawful for the governor, by letters patent under his hand and the seal of the state, to create and erect the subscribers, and if the said subscription be not full at the time then also those who shall afterwards subscribe to the number aforesaid, into one body politic and corporate in deed and in law, by the name, style, and title of "The President, Managers and style of corpora-Company of the Harrisburg and Berlin turnpike road;" and by tion.

the said name the subscribers shall have perperual succession, and all the privileges and franchises incident to a corporation, and shall be capable of taking and holding their said capital stock and the increase and profits thereof, and of enlarging the same from time to time by new subscriptions, in such manner and form as they shall think proper, if such enlargement shall be found necessary to fulfil the intent of this act; and of purchasing, taking and holding to them and their successors and assigns, and of selling, transferring and conveying in fee simple, or for any less estate, all such lands, tenements, hereditaments, and estates, real and personal, as shall be necessary to them in the prosecution of their works, and of suing and being sued, and of doing all and every matter and thing which a corporation or body politic may lawfully do. Sect. III. And be it further enacted by the authority aforesaid,

That the commissioners aforesaid, as soon as conveniently may be after the said letters patent shall be sealed and obtained, shall give notice in at least two newspapers printed nearest the said route, and elsewhere if occasion may require, of a time and place by them to be appointed, not less than twenty days from the publication of the first notice, at which time and place the said subscribers shall proceed to organize the said corporation, and shall choose by a majority of votes of the said subscribers then present, by ballot, to be delivered in person or by proxy duly authorized, one president, eight managers, one treasurer, and such other officers as they shall think necessary to conduct the business of the said company for one year, and until such other officers shall be duly chosen; and the said managers so chosen, and their successors, are hereby authorized to make a turnpike road from the intersection of the Harrisburg and Chambersburg turnpike road and state road, and along or near to the state road towards Washington until within three-fourths of a mile of Eichelberger's tavern on the Carlisle road, thence the nearest and best route to the said Eichelberger's tavern, or to continue on the state road to the Carlisle road, and from thence the nearest and best route to the Berlin and Hanover turnpike road on the south side of Michael Geyselman's mill near Berlin in Adams county; and shall and may make such by-laws, rules, orders and regulations, not inconsistent with the constitution and laws of the United States or of this state, as shall be necessary for the well ordering the affairs of the said company, and generally have like powers, authorities and privileges necessary for carrying on and completing the said turnpik road, and be subject to all the duties, quali-Like powers and privileges, and fications, restrictions, penalties, fines and forfeitures, and be ensubject to like to like tolls and profits in proportion to the distances as are given and granted to the president, managers and company Downingstown are given and granted to the president, such as Ephrata and Harrisburg turnpike road by risburg turnpike of the Downingstown, Ephrata, and Harrisburg turnpike road by court fourth of March, one thousand eight the act passed the twenty-fourth of March, one thousand eight hundred and three: provided, that no toll shall be demanded or
