CHAPTER XCVII.

A SUPPLEMENT to an act entitled, " An act to authorize the governor to appoint commissioners to lay out certain roads therein mentioned and for other purposes."

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That the governor be, and he is hereby authorized and required commissioners to appoint three commissioners to review that part of the state to be appointed. road which lies in Berks county, laid out and marked under the provisions of an act passed the eighteenth day of February, one thousand eight hundred and thirteen; and the said commissioners, after having been sworn or affirmed, shall proceed to perform the said service at such time as the governor shall direct, and if they or a majority of them should be of opinion that there is any alteration necessary in said road, they shall deposit a copy of Draft where dethe draught of such alteration in the office of the clerk of the posited, court of quarter sessions of Berks county; and the said clerk shall enter the same on record which shall be a record of the said road so altered, and from thenceforth shall be to all intents and purposes a public highway, and shall be opened and kept in repair in the same manner as other roads laid out by the au-pair. thority of the court of quarter sessions in Berks county; for which service the said commissioners shall receive each two dollars, for every day they shall be employed in surveying, chaining and marking said road in said county, with reasonable compensation Compensation.
