CHAPTER CVIII.

An ACT to revive the charter of the Presbyterian Church of

Harts-Log Valley in the county of Huntingdon.

SECT. I. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, charter revived. That the charter of incorporation of the Presbyterian Church of Harts-Log Valley, in the county of Huntingdon, be and the same is hereby revived and declared to be in as full force

and effect as if the same had never been forfeited.

Trustees named.

Sect. 11. And be it further enacted by the authority aforesaid, That John Dean, John Crawford, John Canan senior, Conrad Bucher, David Caldwell and William Stewart, be and they are hereby appointed trustees for the said church, and to continue in office until the second Monday in June next. And the election of trustees for the church aforesaid, shall be held on the second Monday in June, annually, or such other day as the trustees may appoint thereafter, any thing in the charter of incorporation to the contrary notwithstanding-

CHAPTER CIX.

A SUPPLEMENT to an act laying a tax on dogs in certain

counties, and for other purposes.

Sect. 1. BE it enacted by the senate and bouse of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That Tax on does in for one dog owned or possessed or kept about any house in laware counties. the counties of Delaware and Chester, the annual tax shall be the counties of Delaware and Chester, the annual tax shall be one dollar; and for every additional dog two dollars, to be assessed, levied, collected and appropriated as is provided for

by the act to which this is supplementary.

Sect. 11. And be it further enacted by the authority aforesaid, That the fact of any dog or dogs being kept or staying about any house shall be deemed sufficient evidence to authorize and require the assessor to return the owner or principal tenant of said house as the owner of such dog or dogs.

Sect. 111 And be it further enacted by the authority aforesaid, That an act laying a tax on dogs in the counties of Washington and Fayette, and for other purposes, be and the same is

hereby extended to the county of Greene.

SECT. IV. And be it further enacted by the authority aforesaid, That the persons designated as appraisers of the damage done to a sheep by a dog or dogs in the act to which this is supplementary shall severally receive for their services the sum of pamages done fifty cents per day, to be paid by the person applying, which &c. sum or sums shall be added to the amount of damages appraised.

SECT. v. And be it further enacted by the authority aforesaid,
That all provisions of the act to which this is supplementary tion. which are supplied or altered by this act, be and they are hereby repealed.

CHAPTER CX.

An ACT supplementary to the act entitled, " A supplement to the act entitled, " An act to establish a board of wardens for the port of Philadelphia and for the regulation of pilots and pilotages and for other purposes therein mentioned."

Sect. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That Auditor general to draw his war if upon a settlement of the accounts relative to the warden's rant in favour of office and the expenses necessarily incurred in conducting the wardens in corbusiness thereof agreeably to the provisions of the act to which this is a supplement, it shall appear that the monies paid by virtue of the said act to the master warden in any year from and after the thirty-first day of March, one thousand eight hundred and thirteen, shall not have been sufficient to pay the said expenses, it shall be lawful for the auditor general to draw a warrant or warrants upon the state treasurer from time to time until the thirty-first day of March, one thousand eight hundred and sixteen and no longer, for the amount of such deficiency, which shall be paid out of the funds created for removing or clearing bars in the river Delaware: provided, Proviso. that the same shall not in any one year exceed the sum of one thousand six hundred dollars in the whole.

SECT. II. And be it further enacted by the authority aforesaid, That that part of the sixteenth section of the act to which this is a supplement which authorizes the harbour master to demand and receive the sum of one dollar for each and every sail free. voyage performed by each and every ship or vessel arriving at the port of Philadelphia, shall not be so construed as to authorize the said harbour master to demand or receive any fee for any steam boat arriving at the port of Philadelphia: pro-
