CHAPTER CXIX.

An ACT erecting part of Wayne county into a separate county.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same, That Part of Wayne all that part of Wayne county lying south and east of a direct county erected into a new one line from the lower end of Big Eddy on Delaware river, to the tobecalled Pike, mouth of Wallenpaupack creek, and thence up the same to the main forks thereof, thence up the south branch to where the most southern branch crosses the north and south road, from thence due west, to the line of Luzerne county, be and the same is hereby declared to be erected into a county henceforth to be called Pike.

SECT. 11. And be it further enacted by the authority aforesaid, Rights & privile the inhabitants of the said county of Pike from and after leges of the inhabitants of the first day of October next, shall be entitled to, and at all times Pike sounty. thereafter, shall have all and singular, the courts, jurisdictions, offices, rights and privileges to which the inhabitants of other counties of this state are entitled by the constitution and laws of this commonwealth, excepting that there shall be but two courts of common pleas and general quarter sessions held in and for said county of Pike in each year.

SECT. III. And be it further enacted by the authority aforesaid, When and where That from and after the first Monday of October next, the courts the courts of of common pleas and general quarter sessions in and for the shall be opened and held at such house as and held.

may be designated by the commisioners of said county to be elected at the next general election in the town of Milford in the county of Pike, until a court house shall be erected in and for said county as hereinafter directed and shall be then held at said court house.

Suits commenc-ed in Wayne county before the 1st of October next shall not be affected by this act.

SECT. IV. And be it further enacted by the authority aforesaid, That no suit or prosecution which has been heretofore commenced, or which shall be commenced in the courts of the county of Wayne before the first Monday of October next shall be delayed, discontinued or affected by this act, but the same shall be completed and carried into execution by the sheriff and coroner of Wayne county as if this act had not been passed.

SECT. XII. And be it further enacted by the authority aforesaid, The mode in That the inhabitants of the county of Wayne and of the county which members of congress &c. of Pike shall elect members of congress and members of the legis-shall be elected lature of this commonwealth, and shall hold their elections in the same mode under the same regulations and make return in the same manner as is directed by the laws of this commonwealth for conducting and making returns of the elections of the county of Wayne: provided always, that the returns from the several Proviso. election districts in the county of Wayne, shall, instead of being transmitted directly to Easton as heretofore, be on the Saturday next after such election, forwarded to the seat of justice of the county of Pike, there to be received by a person appointed in the same manner and for the same purposes as is at the time of passing this act provided by law for transmitting election returns for the county of Wayne to the court house in the borough of Easton.

SECT. XIII. And be it further enacted by the authority aforesaid, That the governor be and he is hereby authorized and required after the first day of June next ensuing, to appoint three discreet

SECT. XIV. And de it further enacted by the authority aforesaid, That the commissioners of the county of Pike who shall be elected at the next general election, shall, within thirty days from and after such election, meet and make the necessary arrangements preparatory to the erection of a court house, and to accommodate the courts until the said court house can conveniently be erected, the commissioners aforesaid shall immediately provide for that purpose a suitable and convenient house in the said town of Milford, and shall immediately proceed to erect a good and sufficient jail in the said town of Milford, and also pro-

vide suitable offices for the safe keeping of the records.

SECT. XV. And be it further enacted by the authority aforesaid, That in order that the county of Wayne shall as nearly as may be bear one half of the expense of erecting public buildings in the county of Pike equal to those at Bethany, the commissioners of the county of Wayne shall direct their treasurer to pay over to the treasurer of the county of Pike in four equal quarterly payments the sum of one thousand seven hundred and fifty dollars.

And be it further enacted by the authority aforesaid, That the sheriff or jailor of the county of Wayne, shall receive all prisoners as aforesaid, and shall provide for them according to law, and shall be entitled to the fees for keeping them, and also to such allowance as is by law directed, for maintenance of prisoners in similar cases, which allowance shall be defrayed and paid by the commissioners of the county of Pike out of the county stock.

Limitation of the nineteenth and twentieth sections of this SECT. XXI. And be it further enacted by the authority afore-said, That the nineteenth and twentieth sections of this act shall be and continue in force for the term of three years, or until the commissioners of Pike county shall have certified to the sheriff that a jail is ready for the reception of prisoners, and approved of by the court and grand jury, who shall enter their approbation, signed by them on the record of said court, and from thenceforth it shall be lawful for the sheriff of Pike county to receive all and every person or persons who may then be confined in the jail of Wayne county, and convey them to the jail of Pike county, and to keep them in custody until they shall be discharged by due course of law.

Papers &c. belonging to the county of Pike to be delivered to the officers thereof &c. SECT. XXII. And be it further enacted by the authority aforesaid, That it shall be the duty of the commissioners of the county of Wayne, to deliver to the commissioners of the county of Pike, when elected, all maps, charts, records and papers, which may of right belong to the county of Pike, or any office therein.

Repealing clause.

SECT. XXIII. And be it further enacted by the authority aforesaid, That so much of any act or acts of Assembly as is hereby altered or supplied, be, and the same hereby is repealed.
