CHAPTER CXLV.

An ACT for the relief of Robert Neilson, and for the redemption of certain certificates of state debt.

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same,* That the state treasurer be and he is hereby directed to pay unto Robert Neilson of Armstrong county, or order, the sum of forty dollars immediately, and an annuity of forty dollars to be paid half yearly during life.

SECT. II. *And be it further enacted by the authority aforesaid,* That the accountant officers be and they are hereby directed to liquidate and settle the amount due on a certificate of funded debt, number thirteen thousand three hundred and twenty-six, issued to Robert M'Nitt for ten pounds ten shillings, and the sum due thereon shall be paid to the said Robert M'Nitt or his legal representatives, by a warrant to be drawn by the auditor general on the state treasurer.

SECT. III. *And be it further enacted by the authority aforesaid,* That the accountant officers be and they are hereby directed to liquidate and settle the amount due on a certificate of funded debt, number twelve thousand eight hundred and forty-five, issued to William Wilson for ten pounds ten shillings; and the sum due thereon shall be paid to Thomas M'Kinley, executor of said William Wilson, late of the county of York, deceased, or order, for the use of his legal representatives, by a warrant to be drawn by the auditor general on the state treasurer.

SECT. IV. *And be it further enacted by the authority aforesaid,* That the auditor general is hereby authorized and required to receive from Mary Anna Scott, of the town of Bedford, a certificate of funded debt, number twelve thousand six hundred and eleven, in the name of Frederick Woer for fourteen shillings, and a bill of credit number thirteen thousand three hundred and thirty-eight, issued under the act of assembly of the seventh of April, one thousand seven hundred and eighty-

one, for fifty shillings, and another bill of credit of the same emission, number twenty-one thousand five hundred and two, for ten shillings; and having settled the amount due thereon, to grant to said Mary Anna Scott a warrant therefor on the state treasurer which shall be paid out of any money in the treasury.

CHAPTER CXLVI.

An ACT compensating Jared Ingersoll for preparing certain bills amending the penal laws.

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same,* That the state treasurer be and he hereby is directed to pay to Jared Ingersoll two hundred dollars as a remuneration for the expenses incurred and services rendered by him in preparing three bills consolidating and amending the penal laws of this commonwealth.

CHAPTER CXLVII.

An ACT to authorize the executors of John Hawk, deceased, to convey a tract of land in East Pennsborough township, in the county of Cumberland.

WHEREAS it is represented to the legislature by the petition of Magdalena Hawk, executrix, and Martin Renninger, executor of the last will and testament of John Hawk, late of the township of East Pennsborough, in the county of Cumberland, deceased, that a certain George Graham conveyed a tract of land situate in said township and county to John Orr, of said township, now deceased, in fee simple, although it was intended by both parties that the use should still remain in the grantor aforesaid: and that the said John Orr conveyed the whole of said land to the above named testator and George Hawk, who afterwards divided the same be-
