## CHAPTER CLXXXVI.

An ACT to authorize the governor to incorporate a company to erect a toll bridge over Juniata river, at or near Millers-town, in the county of Cumberland.

SECT. I. BE it enacted by the senate and bouse of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That Thomas Cochran, Caleb North, William Power, David Watts, William Ramsay of Cumberland county, John Magory, William Bell, David Walker, John Brown, William P. Maclay, Elias W. Hale of Mifflin county, Robert T. Stewart, Joseph Patton, Junior, of Centre county, Robert Allison, William Steel of Huntingdon county, be and they hereby are appointed commissioners to do and perform the several duties hereinafter mentioned: That is to say, they shall on or before the first day of July next, procure three or more books and therein enter as

follows: "We whose names are hereunto subscribed, do promise to pay to the president, managers and company for erecting a bridge over Juniata river, at or near Millerstown in the county of Cumberland, the sum of twenty-five dollars for each share of stock in said company set opposite our respective names, in such manner and proportions and at such times as shall be determined by the president and managers in pursuance of an act of the general assembly, entitled "an act to authorize the governor to incorporate a company, to erect a toll bridge over Juniata river, at or near Millerstown in the county of Cumberland: Witness our hands, the

Sect. 11. And be it further enacted by the authority aforesaid, That notice of the time and places where the said book shall be opened to receive subscriptions for the stock of said company shall be given in one of the public newspapers printed at Carlisle, one at Huntingdon, one at Bellefonte, and one printed at Lewistown, for the period of at least one calendar month prior thereto.

Sect. III. And be it further enacted by the authority aforesaid, When the gover-That as soon as eight hundred shares in the said stock shall have been subscribed the commissioners hereinbefore named or a majority of them shall certify under their hands, the names of the subscribers, and the number of shares subscribed by each subscriber to the governor, who thereupon shall by letters patent, under his hand and the seal of the state, create and erect the subscribers, and if the said subscription be not full at the time, then also those who shall afterwards subscribe, into one body politic and corporate, by the name, style and title of "The president, managers and company for erecting a bridge

SECT. IV. And be it further enacted, by the authority aforesaid, That when thus incorporated the said president, managers and vileges of company shall in respect of the bridge to be erected under the provisions of this act perform the same duties, acts, matters and things, be entitled to all the advantages and the same tolls, privileges, rights and immunities, and be subject to all the rules, conditions, limitations and restrictions, which are provided or imposed on, or granted to the president, managers and company for erecting a bridge over the Allegheny river, opposite the borough of Pittsburg, by the act of assembly passed the twentieth day of March, one thousand eight hundred and ten, as fully and effectually as if the provisions thereof were here enacted at full length.

## CHAPTER CLXXXVII.

A SUPPLEMENT to the act incorporating the president, managers and company of the Anderson's ferry and York turnpike road.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That Henry Share, George Snyder, James Mehaffey, Jacob Gray-Missioners, bill and Thomas R. Buchanon of the county of Lancaster, and John Miller, John Sultzbaugh, George Upp and George Spangler, (surveyor) of the county of York, are hereby appointed additional commissioners to those mentioned in the first section of the original act, to perform with the said first appointed commissioners the several duties required of them by said act.

SECT. 11. And be it further enacted by the authority aforesaid, Route of the That the president and managers so soon as the company shall read to be changed. be organized as is provided in the original act are hereby authorized to change the route contemplated in the original act so as to intersect the Susquehanna and York borough turnpike at such place as the said president and managers shall think proper.
