### CHAPTER X.

**RESOLVED**, by the Senate and House of Representatives of the commonwealth of Pennsylvania in General Assembly met, That the secretary of the commonwealth be and he is hereby authorized and required to cause the act entitled, "An act for the regulation of the militia of this commonwealth," to be printed in pamphlet form, on good paper, and transmit to the brigade inspectors of the several brigades in this commonwealth, a number of said pamphlets equal to the number of colonels, lieutenant colonels, majors and captains in each brigade; and the several brigade inspectors on receiving the same shall distribute one copy to each of the officers as aforesaid, which officers shall respectively deliver the same to their successors in office; and the secretary shall also transmit two copies to the adjutant general, one copy to each major general and brigadier general, and one copy to each brigade inspector, the expense for printing said pamphlets to be paid by the state treasurer in the usual manner.

### CHAPTER XI.

**RESOLVED**, by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, That the governor be and he hereby is authorized and required to cause suits to be brought on the official bonds of the commissioners named in the act entitled, "An act to raise by way of lottery, a sum of money for the purpose of finishing the meeting house in Wilkesbarre, and for protecting the bank of the river opposite the borough from the encroachment of the river," passed the fifteenth day of February, one thousand eight hundred and eight: *provided nevertheless*, that if the commissioners named in the said act, will make it appear to the satisfaction of the governor, any time within four months

from the passage of this resolution, that they have faithfully complied with the requisitions of said act, then and in that case the governor shall cease to take any further proceedings thereon.

### CHAPTER XII.

WHEREAS the commissioners appointed under the authority of the act entitled, "An act to extend the state road laid out from Somerset to the borough of Washington to the western boundary of the state," have not performed the duties required, owing to the absence of one, and indisposition of another of the said commissioners: Therefore,

RESOLVED, *by the Senate and House of Representatives of the commonwealth of Pennsylvania,* That the governor be authorized to appoint one or more commissioners, as the case may require, to supply the place of either or any of the said commissioners heretofore appointed under the act aforesaid: and the ~~commissioner~~ or commissioners so to be appointed, shall perform the duties, ~~be under the restrictions,~~ and receive the same compensation that are expressed and declared in the said act, and the appointment of the commissioners heretofore made, whose places shall be supplied under the authority of this resolution, as soon as new appointments shall be made, is hereby declared to be void.
