## CHAPTER XXXIX.

An ACT authorizing the Governor to incorporate the President, Managers and Company of the Smithfield turnpike road.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Commission Thomas Armat, Daniel Stroud, Jacob Brown, James Burson, John ers named. Houser, Evan Thomas, Samuel Stokes, John Baker, Peter Kocher, John P. Arndt and Stephen Tuttle, be, and they are hereby appointed commissioners to do and perform the several duties here-inafter mentioned, that is to say, They shall, on or before the first day of November next, procure two or more books, and in each of them enter as follows, viz. "We whose names are hereunto subscribed, do promise to pay to the president, managers and company of the Smithfield turnpike road, the sum of fifty dollars each, for every share of stock in said company set opposite to our respective names, in such manner and proportions, and at such times as shall be determined by the president and managers of said company, in pursuance of an act of the general assembly, Books to be entitled "An act authorizing the governor to incorporate the pre-popened sident, managers and company of the Smithfield turnpike road," and shall thereupon give public notice in one or more public papers printed in the county of Northampton, one month at least, Notice to be of the times and places when and where the said books shall be given. kept open to receive subscriptions for stock of the said company, at which times and places some one of the said commissioners shall attend, and shall permit all persons to subscribe in the said books, in their own names or the names of any other persons who shall duly authorize the same, for any number of shares in the said stock; and the said books shall be kept open respectively for the purpose aforesaid, at least six hours in every juridical day for three days, or until said books shall have four hundred shares subscribed, and if at the expiration of the said three days the books aforesaid shall not have the number of shares aforesaid commission-therein subscribed, the said commissioners may adjourn from time ers may adto time, and transfer the said books elsewhere, until the whole journ and number of shares shall be subscribed for, of which adjournment transfer and transfer, the commissioners aforesaid may give such public books.

SECT. III. And be it further enacted by the authority aforesaid. And be it further enacted by the authority aforesaid, That the commissioners aforesaid, as soon as conveniently may be after the said letters patent shall have been issued, shall give notice in one or more of the public newspapers of the county of Northampton, of the time and place, by them to be appointed, which shall not be less than twenty days from the publication of the first notice, at which time and place the said subscribers shall proceed to organize the said corporation, and shall choose, by a majority of votes of said subscribers by ballot, to be delivered into person or by proxy duly authorized, one president and six managers, one treasurer and such other officers as they shall think necessary to conduct the business of the company for one year and

till other officers shall be chosen; and may make such by-laws, rules, orders and regulations, not inconsistent with the laws of the By-laws. Sect. v. And be it further enacted by the authority aforesaid, That as soon as the said company shall have completed five miles or more of the said road, the president and directors shall give 5 miles being notice thereof to the governor, who shall thereupon forthwith apcompleted point three disinterested persons to examine the same, and report tolls may be to him whether the road is executed in a sufficient and workman-taken. like manner, and if their report shall be in the affirmative, then the governor shall, by licence under his hand and seal of the commonwealth, permit the president and managers to erect and fix such and so many gates or turnpikes upon or across the said road, as will be necessary and sufficient to collect the tolls which the company shall be entitled to demand and receive.
