CHAPTER XLIX.

An ACT divorcing Christian Heistand and Barbara, his wife, from the bonds of matrimony.

WHEREAS it has been represented to the legislature, that in the year one thousand eight hundred and thirteen, Christian Heistand and Barbara Reigelsbaugh, of the county of Lancaster, were joined in marriage, and that the said Barbara was within five months thereafter delivered of a male child, and that the parties immediately separated in consequence of the said birth, it being conceded by the parties that the said Christian was not the father of the said child: Therefore,

SECT. 1. BE it enacted by the Senate, and House of Representatives, of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the marriage contract entered into by the said Christian Heistand and Barbara, his wife, late Barbara Reigelsbaugh, be, and the same is hereby dissolved, and the parties respectively set free and apart from all duties and obligations arising from the said contract, as fully and effectually as if they had never been joined in marriage.
