III. *And be it further enacted by the authority aforesaid,* That as soon as the company shall have been incorporated, for making an artificial or turnpike road from Bedford to Stoystown, the governor is hereby authorized to subscribe, on behalf of this commonwealth, for one thousand three hundred shares of the stock of said company: And as soon as the company shall have been incorporated, for making an artificial or turnpike road from Stoystown to Greensburg, the governor shall be, and he hereby is authorized to subscribe, on behalf of this commonwealth, for one thousand three hundred shares of the stock of said company.

SECT. IV. *And be it further enacted by the authority aforesaid,* That so much of the said act to which this is a supplement, as is hereby altered or supplied, be, and the same is hereby repealed.

## CHAPTER LXVI.

An ACT directing the secretary of the land office, to issue patents to the assignees of John Nicholson, for certain lands therein mentioned.

WHEREAS it has been represented to the legislature, that John Nicholson, on the twenty-first day of April, seventeen hundred and ninety-four, applied for two hundred and two thousand four hundred acres of land, and gave a check on the Bank of Pennsylvania for the purchase money, which was presented and dishonored; upon which he tendered twenty-seven thousand two hundred and sixty-one dollars and thirty-three cents, the purchase money, on the fourteenth day of June, seventeen hundred and ninety-four, which was refused: and that the said John Nicholson transferred his right to the said application, to Joseph Boone, who obtained the decree of the board of property for warrants to issue in his favor thereon, which was transferred by him to Philip Nicklin and Robert E. Griffith, merchants, in company; and it having been found, by exploring the county, that about eighty thousand acres remained unappropriated, which might be applied in part satisfaction of the said application; on the nineteenth of March, eighteen hundred and five, the said Philip Nicklin and Robert E. Griffith paid, in moieties, ten thousand seven hundred and twenty dollars, the purchase money on eighty thousand four hundred acres, upon which warrants there-

for issued to the said Nicklin and Griffith: And whereas, doubts have been suggested, whether interest should not be calculated upon the purchase money paid upon issuing the said warrants, from the twenty-first of April, seventeen hundred and ninety-four, until the day of issuing the said warrants: Therefore,

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the secretary of the land office be, and he is hereby directed to issue patents to the said original warrantees, or their legal representatives, upon the warrants granted for the said eighty thousand four hundred acres, they paying for the surplus lands returned upon the surveys, with interest thereon from the date of the warrants, and also paying the office fees: Provided, That this act shall not in any way affect the right of other persons.*

## CHAPTER LXVII.

An ACT for the relief of Jacob Bower.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the board of enquiry, established by the act entitled "An act for the relief of disabled, aged and poor revolutionary officers and soldiers," passed the twenty-fifth day of February, one thousand eight hundred and thirteen, be, and they are hereby directed to place Jacob Bower, late a captain in the Pennsylvania line, in the army of the United States, on the book opened by them in their offices respectively, and allow him an annuity, which, together with the sum he now receives, shall be equal to one fourth of his pay, to continue during life, payable half yearly, to commence from the first day of January, one thousand eight hundred and fifteen.*
