Delaware, contrary to the true intent and meaning of the said recited clause of the said agreement entered into by the states aforesaid, and in direct violation thereof, and as evil consequences are likely to result from an infraction of said agreement, by the passage of the aforesaid act of the legislature of the state of New Jersey, if submitted to by this state, not only as it has a tendency, if the wing dam should be erected within the bed of the river Delaware, to injure the navigation thereof, but as it will be mischievous in destroying the public confidence of the one state in the declarations solemnly pledged by any other state: Therefore,

RESOLVED, by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, That they do most solemnly protest against the passage and operation of the act of the legislature of the state of New Jersey, entitled "An act to enable Daniel W. Cox, Samuel Wright, junr and Peter T. Smith, his or their heirs or assigns, to erect a wing dam in the river Delaware, to connect Yard's island with the main land at Bloomsbury," passed on the fourth day of February, in the year of our Lord one thousand eight hundred and fifteen, and every part therefor, as being an infraction of the aforesaid agreement, entered into by the said states of New Jersey and Pennsylvania. And.

by the said states of New Jersey and Pennsylvania. And, RESOLVED FURTHER, That the governor of this state be directed to transmit an authenticated copy of the foregoing resolution to the executive of the state of New Jersey, in order that the same

may be laid before the legislature thereof.
