

CHAPTER XLVII.

An ACT repealing the "Act to encourage the raising of swine," so far as the same respects the borough of Mercer.

SECT. I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the act, entitled "An act to regulate fences, and to appoint appraisers in each township in the counties of Bedford, Northumberland, Westmoreland, Washington and Fayette, and to encourage the raising of swine," passed the twenty-seventh day of March, one thousand seven hundred and eighty-four, (except the repealing clause) be, and the same is hereby repealed so far as the same respects, and is in force in the borough of Mercer, in the county of Mercer, agreeably to the present limits of the said borough.*

CHAPTER XLVIII.

An ACT authorising James Wilson, of York county, to convey the right to a tract of land of Mary Wilson, a lunatic, and for other purposes.

SECT. I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That James Wilson, of Chanceford township, in the county of York, be, and he is hereby authorised and empowered to convey, by deed or deeds, all the right, title, interest and claim of his sister, Mary Wilson, a lunatic, of, in and to a certain tract of land, devised to the said Mary Wilson and others, by the last will and testament of her father, John Wilson, late of Drumore township, Lancaster county, deceased; which deed or deeds of conveyance, shall be as good and valid in law, to all intents and purposes, as if the said Mary Wilson had conveyed the same while of sound mind and memory: Provided, That the said James Wilson shall, before he proceed to convey the estate of the said Mary Wilson, enter into recognizance, with sufficient sureties, before the court of common pleas of Lancaster county, that all the money arising from the sale of said tract of land, which may come to the share of the said Mary Wilson, after paying the just debts of the said lunatic, be so disposed of as will be most beneficial for her, and he shall, when required, ex-*

hibit an account, on oath or affirmation, to the orphans' court of said county.

CHAPTER XLIX.

An ACT authorising and empowering John More to execute a title to George Forney, for a certain real estate therein mentioned.

WHEREAS, an act passed the twentieth day of March, one thousand eight hundred and twelve, authorising George Fiedt, trustee of the Lutheran congregation in Upper Paxton township, Dauphin county, to sell a part of a tract of land belonging to said congregation, to defray the expenses of erecting a house of public worship: *And whereas*, the proceeds of said sale were not sufficient to defray the debts of said congregation, and the members of said congregation have prayed the legislature to pass a law authorising the sale of ten acres to pay off said debts: Therefore,

SECT. I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That* John More, the present trustee of the Lutheran congregation in Upper Paxton township, Dauphin county, or his successors, he, and he is hereby authorised and empowered to make and execute a good and sufficient deed, in fee, for ten acres of land, situate in said township, adjoining lands of John Noll, George Forney and others, to the aforesaid George Forney, his heirs and assigns, in as full and ample a manner as if the same was the private property of the said trustee, he applying the proceeds of the money arising out of such sale, in such manner as shall be directed by said congregation.
