CHAPTER LXXVII.

An ACT to authorise George Eisenhuth, George Orwig, John Orwig and Jacob Orwig, to dig, establish and support a mill-race on the north side of Penn's creek, near the town of New Berlin, in the county of Union.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That George Eisenhuth, George Orwig, John Orwig and Jacob Orwig, of the county of Union, their heirs and assigns, be, and they are hereby authorised to dig, establish and support a mill-race not exceeding eighteen feet in breadth at the surface of the water therein to be conveyed, and of a sufficient depth to convey the water from a mill proposed to be built by them near the town of New Berlin, in the county of Union, across the public road leading from New Berlin aforesaid to Swinefordtown, in the county aforesaid, at the north end of the abutment of a bridge now erected across Penn's creek on said road: Provided the said George Eisenhuth, and George, John and Jacob Orwig, their heirs and assigns, shall erect and keep in repair all bridges over said race, and shall first exhibit to the court of quarter sessions of the said county, a draft of the race and the manner of bridgeing the same: And provided also, That the same shall be approved of by the said court and entered upon the records thereof, in such manner and with such security as the said court shall direct.

CHAPTER LXXVIII.

An ACT to provide for the election of a constable in the borough of Columbia, in the county of Lancaster.

Sect. r. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the electors residing in the borough of Columbia, in the county of Lancaster, shall, at the usual time appointed by law for the election of constables yearly, and every year after the passage of this act, elect two suitable persons, being citizens of said borough, for the office of constable, and shall return the names of the persons so elected, to the next court of general quarter sessions of the peace to be holden for said county, and the said

court shall appoint one of them constable for said borough, which constable, when so appointed by the court, shall have the same power, and be subject to all the penalties and regulations, which constables have and are subjected to under the laws which now or hereafter may exist within this commonwealth.

CHAPTER LXXIX.

An ACT providing for the sale of the State House and State House Square in the city of Philadelphia.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the governor be, and he is hereby authorised and required, on Commissionor before the first day of May next, to appoint three commissers to be apsioners, neither of whom to reside within the city or county of Pointed. Philadelphia, whose duty it shall be to proceed and lay out a street or streets through the public ground called the "State House Square," in the city of Philadelphia, in such manner as in their opinion will most conduce to the value of the property.

Sect. 11. And be it further enacted by the authority afore-

said, That when the said commissioners shall have laid out the To lay out state house square as aforesaid, they shall divide it into lots the square in suitable for building, so as that in their opinion they will accommodate purchasers and produce the best price, and having so laid out the ground, they shall deposit a draft or map thereof in the office for recording of deeds in the city of Philadelphia,
