SECT. 11. And be it further enacted by the authority aforesaid, That the said Edward Duffield and Joseph K. Swift, before they proceed to sell the said tract of land, shall enter into a recognizance with sufficient sureties, before the orphans' court of the city and county of Philadelphia, conditioned for the faithfulexecution of the power hereby given, and for the expenditure and distribution of the proceeds of sale, in such manner as will best effect the intention of the testator: Provided always, That the legal rights of all other persons shall be, and they are hereby reserved and shall remain as fully and effectually as if this act had not been passed.

CHAPTER XC,
