CHAPTER III.

AN ACT

Authorising Esther Ottinger, Jacob Holgate and Aaron Keyser, executors of John Ottinger, deceased, to sell and convey part of a tract of land therein mentioned.

said executors, or the survivor or survivors of them, are hereby authorized to execute a conveyance to the purchaser or purchasers of all the right and title to the estate sold, which the said John Ottinger had therein, at the time of his decease. Provided, That the quantity of land sold, shall not exceed twenty five acres; and that the said Esther Ottinger, Jacob Holgate and Aaron Keyser, before they receive any part of the purchase money, shall enter into a recognizance in the Orphan's court for the county of Montgomery, with sufficient sureties to the satisfaction of the said court, conditioned. that the duties mentioned in this act, shall be faithfully performed, and the proceeds of the sale hereby authorized, be applied to the payment of the debts of the testator in due course of law, and the balance, if any, disposed of as far as practicable in conformity with the intentions of the said testator, as expressed in his last will and testament.
