## CHAPTER XLVIII.

#### AN ACT

To authorise and empower the executors of John Gemmil, junior, deceased, and the administrators of Zachariah Gemmil, deceased, to execute a deed for a certain tract of land in Mifflin county.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met. and it is hereby enacted by the authority of the same, That it shall and may be lawful for the executors of John Gemmil, junior, deceased, and the administrators of Zachariah Gemmil, deceased, and they are hereby empowered to join with the surviving heirs and legal representatives of John Gemmil, senior, deceased, who are or may be of full age, in executing a deed in fee simple for a tract of land in Mifflin county, Fermanagh township, adjoining lands of James Banks and others, containing two hundred and fifty-four acres, more or less, to Andrew Banks and James Banks: Provided, That the said deed shall not pass any greater interest or estate than was vested in the said John Gemmil, senior, in his life time.

## CHAPTER XLIX.

#### AN ACT

For the relief of John Snyder, Daniel Stoy, Adam Specht and Henry Lebo, old soldiers.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the state treasurer be, and he is hereby directed Gratuity and to pay to John Snyder, late of York county, or his order, annuity of forty dollars immediately, and forty dollars annually, to be \$40 to John paid half yearly during his life, to commence on the first day Snyder. of January, one thousand eight hundred and seventeen.

Sect. 2. And be it further enacted by the authority afore-Gratuity of said, That the state treasurer be, and he is hereby directed to \$200 and an pay to Daniel Stoy, of Somerset county, or his order, two nuity of \$50 hundred dollars immediately, and an annuity of fifty dollars to Danl Stoy. for his meritorious services, to be paid quarter yearly during life, commencing on the first day of January in the year one thousand eight hundred and seventeen.

Sect. 3. And be it further enacted by the authority aforesaid, That the state treasurer be, and he is hereby directed to Gratuity and pay to Adam Specht, of Union county, or his order, forty dolannuity of \$40 to Adam lars immediately, and forty dollars annually during his life, to be paid half yearly, to commence the first day of January, one thousand eight hundred and seventeen. SECT. 4. And be it further enacted by the authority aforesaid, That the state treasurer be, and he is hereby directed to Gratuity of \$40 to Henry pay to Henry Lebo, of Lycoming county, or order, the sum of forty dollars as a gratuity.
