SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General

# CHAPTER LXIII.

#### A SUPPLEMENT

To the act entitled "An act to incorporate the town of Waynesburg, in the county of Greene."
